Course Catalog Description:

This course will examine topics in the history of the San Antonio area from its indigenous roots thousands of years ago to the modern era. Topics may focus on specific themes in San Antonio history such as culture, environment, military, politics, education, gender, race, ethnicity, or others. Prerequisite(s): HIST 1301, HIST 1302.

Student Learner Outcomes:

Upon completion of this course, the student will be able to:

- 1) understand and evaluate the roles that many different groups of people played in San Antonio history
- 2) explain major challenges in San Antonio history
- 3) explain historical preservation efforts in San Antonio
- 4) analyze primary and secondary sources related to San Antonio history
- 5) develop a research project that analyzes an aspect of San Antonio history

No Extra Credit will be offered. I do not add points onto final grades even if a student is close to another grade.

Graded work should be returned within 2 weeks if not sooner.

Attendance:

Regular attendance is required. I take attendance at the beginning of class, so if you enter the class significantly late, you will be counted absent. If you leave class early, you will be counted absent as well. As much of the course work happens in class, missing four classes or more will

result in a loss of one letter grade (-10 points) for this class. All students (whether present or absent) are responsible for all announcements made in class and all assignments given in class because it is sometimes necessary to make changes to the syllabus.

Make-ups:

Exams can only be made up in the case of a documented emergency. Essays are due by the date and time marked on the syllabus. If submitted late, essays will accrue late penalties of five points per day late. The penalty will be applied to essays submitted more than 15 minutes late but won't accrue the next five points until 24 hours later. All makeups (including late essays) must be completed before the last day of classes per the academic calendar (prior to final exam week). All essays are due on blackboard through a turnitin assignment. I will not accept essays that have not been submitted through turnitin in blackboard. Keep your submission receipt in case there is a problem. If you have an emergency and cannot submit your essay on time, you must talk to me right away and provide documentation of the emergency. Otherwise, your essay grade will receive the penalty. You also need to use a program that turnitin accepts (like Microsoft Word).

Academic Misconduct Policy

others for writing. Use of any AI-generated work in this course constitutes academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Turnitin: You will submit your papers to the turnitin assignment in blackboard. Once submitted, you will get a report with a percentage. Lower is better, and zero is best. But, the number doesn't tell the whole story. No matter how low your number is, click on the color next to the number (green, yellow, red) to see your actual results. Take a look at what is not original. If the matches are all citations, then you are fine. If it is a common phrase, it is OK (i.e., "the peculiar institution"). If a whole sentence comes up, you need to look at that. If a sentence comes up, minus 3 random words, you need to look at that too. All work must be your own. Changing a few words does not make it your own. You can submit your paper and make changes until the due date. When you resubmit, it can take one or two days for your originality report to be created. Turnitin now checks for AI as well.

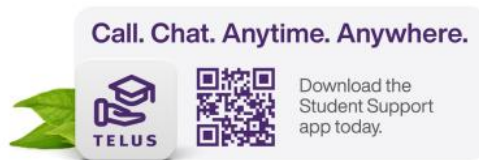

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Any student receiving federal financial aid who does not attend by the census date will have their financial aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester, a Care report will be submitted, and you will possibly be dropped from the class. Your financial aid may have to be recalculated and a portion of your federal aid may have to be returned to the DoE.

SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Students' Rights

2. Each student shall have the right to participate in all areas and activities of the University, free from any form of discrimination, including harassment, on the basis of race, color, national or ethnic origin, religion, sex, disability, age, sexual orientation, gender identity, gender expression, and pregnancy/parenting or veteran status in accordance with applicable federal and state laws.
3. A student has the right to personal privacy except as otherwise provided by law, and this will be observed by students and University authorities alike.
4. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

Students' Responsibilities

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, [Student Code of Conduct](#), on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
4. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning.
5. A student has the responsibility to check their university email for any updates or official university notifications.

We expect that students will behave in a manner that is dignified, respectful, and courteous to all people, regardless of sex, ethnic/racial origin, religious background, sexual orientation, or disability. Conduct that infringes on the rights of another individual will not be tolerated.
