Course Overview

MATH 1342: Students will study the collection, analysis, presentation and interpretation of data, and probability. Analysis includes descriptive statistics, correlation and regression, confidence intervals and hypothesis testing. Appropriate technology used. This course meets the standards for the Mathematics category of courses under the core curriculum.

MATH 0342: This course supports students in developing skills, strategies, and reasoning needed to succeed in MATH 1342, including communication and appropriate use of technology. Topics include the study of numeracy and the real number system; probability and quantitative relationships; mathematical models; and problem solving. This support course is not a college-level course and should be graded Pass/Fail.

MATH 1342 Spring 2025

Student Learning Objectives: Upon completion of this course, students will:

- Use data collection and statistics to reach reasonable conclusions.
- Understand the principles of data presentation and description.
- Compute and interpret probabilities using probability rules and combinatorial principles.
- Understand the role of probability within statistics.
- Recognize and explain various sampling distributions for discrete and continuous random variables.
- Comprehend the principles and computation techniques regarding confidence intervals, simple linear regression, and hypothesis testing.

Course Requirements and Expectations

Class Attendance: Students are expected to attend lectures. Be aware of what has been covered in every class and any announcements and course policy changes made in class. Announcements and changes will also be communicated through Blackboard. You are welcome to e-mail me when you have questions. However, it is your responsibility to learn the material.

Learning New Content: Lectures will be held during the scheduled meeting times of the course. The content of these lectures is essential for successful completion of your assignments.

Homework: There will be weekly homework assignments. All homework and quizzes will be completed online in MyLab. Read the announcements in Blackboard for all instructions. All due dates are listed in MyLab. The assignments must be completed before 11:59 PM on the day listed in the due date. The homework may be attempted multiple times in order to increase your homework grade. There is no limit to the number of attempts. No late assignments will be accepted nor make-ups allowed.

Quizzes: There will be a quiz assigned every other week. All due dates are listed in MyLab. Quizzes may be attempted up to three times, and each quiz attempt has a time limit. Only the highest score will be counted. No late assignments will be accepted nor make-ups allowed.

Exams: Three unit tests are scheduled during the semester. The policy regarding use of calculators on the exams is stated above under the course material section.

Any missed exam will be given a grade of 0. If you are unable to take an exam because of a sudden emergency or a university-sanctioned event, contact me as soon as possible. All details regarding valid excuses and missed exams is at the discretion of the instructor and may differ slightly from what is written here. The lowest exam grade will be dropped and replaced with your Final Exam grade. The exams will be taken during the scheduled meeting time of the course.

Final Exam: In order to pass this class students must take a comprehensive final exam scheduled during Finals Week. Final exams cannot be rescheduled or missed (for dire and unforeseen medical or family emergencies, students must consult with me). The final exam grade will be used to replace your lowest unit exam grade.

<u>Financial Aid and Verification of Attendance</u>: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
