Course Description Directed Research. Individual instruction course for advanced and qualified undergraduates to obtain supervised research experience in psychology. Student will assist with a research project by working under the individual guidance of a psychology faculty member. Requirements may entail library research, data collection, data entry, statistical analysis and or assistance in planning and conducting parts of a research project. A paper/for credit assignment on the research experience is required. Consent of instructor required. Variable credit for a total of 6 maximum. Prerequisites: PSYC 2301, PSYC 2388. Prerequisite or corequisite: PSYC 3488.

Objectives

As a result of taking this course, you will be able to:

- Get hands-on experience in data collection and analysis
- Find and summarize literature related to a specific research topic of interest
- Develop hardware and software for data collection
- Analyze actual research data
- Prepare to present research studies to the world Lab Meetings

We will have regular meetings throughout the semester to discuss progress on deliverables, assess the status of projects, and help make sure everything is running smoothly.

Grades

Each student will work with instructor to create a list of deliverables for the semester. Your grade will be based upon the number and quality of deliverables accomplished. The total number of points for all deliverables will be 100, and grades will be determined as follows: A = 90-100 Points B = 80-89 Points C = 70-79 Points D = 60-69 Points F = 59 and fewer

Points

Students will be expected to participate in all aspects of the class. Missing meetings and missing deadlines will result in a lower grade. In addition, students are expected to keep

track of their hours spent on class work if they are in the 1, 2, or 3-credit sections. That will be turned in usually twice a semester, or once in the summer. Volunteers (PSYC 4051) will not need to do this. They are, however, expected to attend all meetings. A final project will also be necessary for assessment, for students taking the course for 1, 2, or 3 hours of credit.

Time

Commitment Federal law mandates that each "hour" of course credit requires two hours outside of class. As such, we expect three hours per week of activity related to the course for each hour of credit. This includes time spent in scheduled lab meetings, finding and reading articles, preparing presentations, and so on.

Quality of Written Work

All written work should be academic quality submitted in APA format in order to expect full credit.

Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AIgenerated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.
