Course Description and Materials

Catalog Description: The course encompasses the study of limits, continuity, and derivatives of algebraic, trigonometric and transcendental functions and related applications to include maximizing or minimizing a function and rate of change problems. The course also introduces the definite integral, the Fundamental Theorem of Calculus and application to calculation of areas. Curve sketching and graphing tools will be utilized in exploring these concepts.

Math 2113 and Math 2313 help students develop Critical Thinking, Communication, and Empirical and Quantitative Skills by focusing on student understanding of the calculus concepts to include recognizing, identifying, solving, analyzing, and explaining appropriately model applicable real-world situations.

Prerequisite: Math 2312 Pre-Calculus with a grade of "C" or higher, or equivalent.

Required Textbook: Essential Calculus, Early Transcendentals by James Stewart (2nd edition) with WebAssign. Cengage Publishing with ISBN-13: 978-1-133-11228-0.

Student Learner Objectives: Upon completion of this course, you will be able to:

- Develop solutions for tangent and area problems using the concepts of limits, derivatives, and integrals.
- Interpret and draw graphs of algebraic and transcendental functions considering limits, continuity, and differentiability at a point.
- Determine and explain whether a function is continuous and/or differentiable at a point using limits.
- Apply differentiation rules to differentiate algebraic and transcendental functions.
- Identify and apply appropriate calculus concepts and techniques to provide mathematical models of real-world situations, and to determine and explain solutions to applied problems.
- Evaluate definite integrals using the Fundamental Theorem of Calculus.
- Recognize and articulate the relationship between derivatives and integrals using the Fundamental Theorem of Calculus.

NOTE: This class meets four times each week. Aside from the four hours that you spend in class each week, you should devote at least another 4~6 hours to studying on your own: reading the book and my lecture notes, working out the exercises and your homework assignments, and solving extra problems for practice etc. You are responsible for all materials/topics discussed in this class.

Active Learning and Inquiry Based Learning: This course implements active learning and inquiry-based learning approaches throughout, and you are strongly encouraged to preview the teaching materials and be aware of many class participation and self/group study activities.

Course Expectations and Requirements

Class Attendance: Your active participation strengthens our learning community, and your questions and perspectives help everyone develop deeper understanding. I encourage you to attend classes regularly and be prepared to participate in discussions, in-class exercises, and problem presentations. Class attendance is taken at the beginning or at the end of each class. In addition, if an unavoidable situation prevents you from being on time or if you must leave early, **please minimize class interruption.**

Quizzes: There will be a 15~20-minute in-class quiz emphasizing the most recently covered topics roughly every two weeks, and there will be around 6 in total where only the best 5 of them will be counted as portion for your final grades.

Examinations: There will be three exams throughout the semester, each administered at the scheduled time. Exceptions may be made for legitimate reasons, but they must be approved by me. If you are unable to attend an exam, you must notify me formally within 24 hours of the scheduled exam time. In certain circumstances, someone else may notify me on your behalf. You will need to provide a valid reason for your absence, along with supporting documentation. You can notify me either via email or in person with a written notice. If you know in advance that you will be unable to take the exam at the regular time, please contact me ahead of time to make alternative arrangements. Failure to follow this procedure will result in a **GRADE OF ZERO** for the missed exam.

Dates of Midterm Tests: The exact dates will be announced at least a week ahead of time when the time comes both on Blackboard and via email. They can be either in-class exams, taken home projects, and/or hybrid.

Test 1 covers Chapters 1~2(only selected important topics).

Test 2 covers Chapters 3~4 (only selected important topics).

Final exam is comprehensive (only selected important topics).

NOTE: Graphic TI-83 or higher calculators, cell phones, laptops, i-pads, kindles, and any other electronic or mobile devices will absolutely be **NOT** allowed during the quizzes/tests/final exam. Once found, your quizzes/tests/final exam will receive a **GRADE OF ZERO**. If this happened in a recursive manner, then the instructor would report to the university as an academic dishonesty issue.

Assignments: All homework assignments must be completed online through WebAssign. Please refer to the announcements on Blackboard for detailed instructions, and note that all due dates are listed in WebAssign. If you are unable to finish all the questions, try your best to complete as many problems as possible. Do not wait until the last day to begin your homework; instead, work on the problems consistently throughout the week. You may attempt each assignment multiple times to improve your homework grade.

Electronic Devices: Cell phones, laptops, iPads, Kindles, and any other electronic devices must be turned off and stored away during class. If you are observed texting or using an electronic device during class, you will receive a warning. Continued misuse may result in being asked to drop the class.

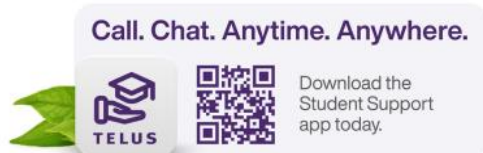
IMPORTANT POLICIES AND RESOURCES

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
