**Course Description:** This course is an introduction to the procedures of state and local governments within the United States, with particular emphasis on Texas. The processes of the Texan political system will be lectured on, analyzed over, and discussed within class. Topics include the history of state government and the Texas constitutional legacy, the state legislature, political parties, political participation as well as the state court systems and current administrative issues within state government. County and municipal organizations' interactions with the state will also be examined. Throughout the course students will learn numerous facts in order to better articulate insightful responses toward the various issues occurring within state and local politics.

# **Student Learning Objectives:**

1. Understand and explain the origins and continual development of the Texas constitution.

2. Exhibit an understanding of state and local political systems as well as their relationship with the federal government.

3. Describe separation of powers and checks and balances in Texas, in both theory and practice.

4. Demonstrate knowledge of the legislative, executive, and judicial branches within the Texas government.

- 5. Evaluate the roles public opinion, interest groups, and political parties play in Texas.
- 6. Analyze the state and local election process.
- 7. Describe the rights and responsibilities of the Texan citizenry.
- 8. Examine issues, policies, and political culture of Texas.

<u>Online Quizzes</u>: Quizzes will be made available online via Blackboard in Course Content. They will consist of multiple-choice questions concerning key terms and concepts for the given chapter of that week. You will have 35 minutes to complete the quiz and may use your eBook. You <u>must</u> work alone.

<u>Online Exams</u>: Exams will include a variety of questions (essay questions, some multiple choice) and will evaluate your knowledge of both the readings assigned as well as the materials covered in class lectures. It is expected you put your critical thinking skills to work. The exam will be essay-heavy, therefore, grammar, spelling, sentence structure, etc. will be crucial in obtaining the highest grade possible. The exam will have a time limit and you <u>must</u> download **Respondus Lockdown** at the beginning of the semester in order to access each exam; this will lockdown your browser to prevent cheating. This is NOT an open-book exam. [Lowest regular exam grade will be dropped].

<u>Blackboard Discussion Questions</u>: Weekly discussions within the "discussion" tab within your Blackboard course page consist of a two-step process: You will be asked key discussion questions weekly and must provide a <u>thorough paragraph answer</u> that would constitute a <u>half a page</u>. These discussion question responses <u>MUST</u> be typed in YOUR OWN WORDS (not the authors) and <u>must</u> utilize political science terminology and insight. These responses will be helpful in preparing you for future exam essay questions. **NOTE**: For full credit, you must respond to <u>1</u> of your classmates' responses. Be sure to comment on their main point and insert your perspective on whether you agree or disagree and why. **NOTE**: DO NOT USE QUOTES FROM YOUR TEXTBOOK & be sure to watch your grammar, sentence structure, spelling, capitalization.
