Course Description (from the A&M-SA Course Catalog)

This course is designed to assist first-year students in adjusting to university expectations through enhancing quantitative reasoning skills and acquiring essential skills for academic success.

Course Overview

This course is designed to assist first-year students in adjusting to university expectations, acquiring essential academic success skills, and exploring different career paths. The course focuses on accessing university resources, and developing self-awareness, agency, and personal responsibility. Students will also become active members of the campus community.

Course Promises

This course makes a set of promises to you (assuming you fulfill the expectations below). By the end of the semester, you should be able to:

1. Exhibit growth in self-awareness, agency, and personal responsibility
2. Demonstrate knowledge and skills in quantitative reasoning
3. Adapt and apply appropriate academic strategies to courses and learning experiences
4. Identify and apply strategies to effectively manage time and priorities
5. Identify relevant academic policies, processes, and resources relevant to your academic success
6. Develop goal-setting strategies to enhance academic and career readiness.

Course Expectations

This course will only fulfill these promises if you promise the following in return:

Attend classes. This course will rely largely on class content and discussion. For this format to succeed, you must be present AND on time. You will earn an absence if you arrive 15 or more minutes after class has started. Excessive tardiness will also be penalized. You will receive points for attendance and many in and out of class assignments will be contingent on information from class. To earn full participation points, you must attend class and actively participate. **You may miss up to four classes. Five absences may result in you being dropped from the course. The 4 absences may include quarantine and/or isolation for COVID-19. If you need to miss more than 4 days due to extracurricular activities, communication must be provided by your organization's coach or advisor/sponsor. There are no excused or unexcused absences. The instructor will notify and contact you if you are in danger of being dropped. The instructor takes attendance based on recording the class session and physically looking after class at everyone who is there. If you are ever present and the instructor counts you as absent in error, please contact the instructor immediately. The instructor will notify you if your attendance is concerning and there is a risk of reaching more than four absences.**

Please also make sure your camera and microphone are on and working. Students who do not respond or do not participate in breakout rooms will be counted as absent.

To be attentive and participate in class. I expect all students to actively participate during class both verbally and nonverbally. Participation does not simply mean speaking, although that is essential. I realize there are a variety of ways students can participate (e.g., following discussions with your eyes and ears, asking questions, sharing, reading, writing, individual reflection, presenting, collaboration). I hope that you will strive to stretch yourselves beyond your preferred ways of learning and your comfort zone. I encourage you to contribute thoughtful comments and questions, as well as to listen carefully to your peers' contributions and respectfully respond to others' comments. The success of our mutual learning from each other depends upon preparation and active participation in all aspects of the course.

To complete required assignments in a timely manner. Assignments provide you with both informal and formal opportunities to articulate your responses to the issues and topics we will discuss. You will get the most out of the course if you turn in your work on time. Extensions require at least a full day's advance notice prior to due dates and approval from me. It is vital that you follow basic grammar rules in order to get full credit for assignments. No matter how short or long the response, make sure you check

for grammar and standards of academic writing. All responses are a reflection of you and are intended to prepare you for academic and professional writing.

Late Work Policy: It is very important that you complete work on time. Employers will ask you to complete your projects and work tasks on time. It is best to start the practice of submitting work on time and by the deadline now. The instructor will communicate when assignments are due (date and time). There is an automatic point deduction for late work:

- Assignments are due generally one week after they are given.
- Work submitted beyond the stated deadline one day late to 30 days after the deadline: 25% reduction in points.
- Work that is more than 30 days late: 50% reduction in points
- Starting in April, there are instances where it might not be possible to submit work more than 30 days late. For instance, if an assignment is given in mid-April, the latest I can take the assignment is by our last week (classes end on May 5,).
- Accepting work during the week of finals (May 6-13) is at my discretion and might not be possible.
- No work can be accepted and assignments will close by May 13th.
- Shortly after the deadline passes for an assignment, any students who do not submit the work will receive a no-credit grade (noted as a 0). This does not mean your final grade is a 0; it simply means I did not get anything from you. Please take action to complete and submit the assignment to get partial credit.
- **I urge all students to submit assignments on time. One assignment late is not concerning. However, if you routinely don't submit work, the backlog will get substantial. It could be overwhelming and exhausting to complete large amounts of past due assignments in a short period of time (also think about your other classes and the work you will get from them). I urge everyone not to fall behind on your work. It is much less stressful to do assignments one by one and as they come. While late work is accepted, set yourself for the greatest amount of success by completing and submitting work on time!**

All policies in the syllabus concerning late work and other procedures are designed to ensure fairness. It is not fair for the instructor to create a policy for one student that he does not give to another student. Exceptions to any policy generally will not happen unless the instructor does that for each student. Please contact your instructor with questions.

Assignments and Evaluations

To be successful in this course you are expected to complete all assignments on time. Assignments must be submitted to the correct location to be considered on time. Assignments will be graded based on quantity and quality with rubrics for each assignment provided in Blackboard.

If you miss an in-class assignment, meet with your Instructor, Peer Leader, or a classmate to catch up on any work you may have missed.

 - Faculty contact meeting: 50 points (this is where the instructor will reach out to you or engage with you in person or by messaging) to check in with you and see how you are doing this semester. The instructor will give detail on this; **while talking to your instructor in person is not required, I am hopeful we can ultimately talk or at least exchange messages. Please note: If you contact the instructor or exchange a message at some point in the semester (or set up a formal meeting – simply talking before or after class does not count) counts for this meeting.**

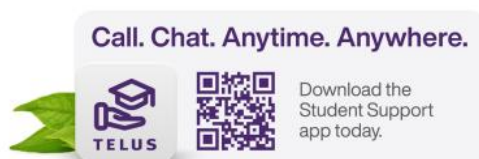

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Any student receiving federal financial aid who does not attend by the census date will have their financial aid terminated and returned to the DoE. The Six-Drop Rule: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

4. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

Students' Responsibilities

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, [Student Code of Conduct](#), on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
4. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning.
