### **Course Description & Objectives**

In this class, we will work on the following themes of Texas Government: the origin and development of the Texas Constitution, structure and powers of state and local government, federalism and inter-governmental relations, political participation, the election process, public policy, and the political culture of Texas. This course fulfills the Government/Political Science foundational component area of the core and addresses the following required objectives: Critical Thinking, Communication, Social Responsibility, and Personal Responsibility.

By the end of the course, you will have a comprehensive understanding of the structure of our state government and will understand better how our state is supposed to work. **Please be advised that this is an ONLINE class, which means that all the instruction, activities, and assignments will be provided online.**

### **Learning Outcomes**

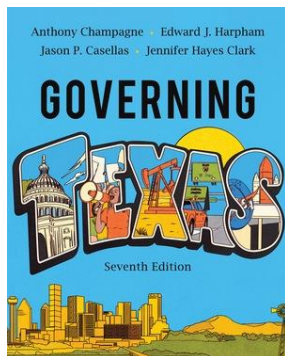
1. Explain the origin and development of the Texas Constitution.

expiration of their original deadlines. Each assignment will have this information listed in its instructions (AND listed in this syllabus and on its schedule).

Students can get their scores at any time during the semester on Blackboard Ultra. Any appeals concerning your course grade must be submitted by your official Jagwire email. Also, it is the student's responsibility to immediately notify the instructor of additional accommodation (officially sent to the instructor by email through the Dean of Students Office).

### **What happens if a student does not attend class?**

If you do withdraw from the course, you can receive a "W." But you must withdraw from the course prior to the last withdrawal date published in the schedule (included in this syllabus schedule). YOU must submit a withdrawal request in ACES via the "student course withdrawal" link. Contact your advisor, or the Admissions and Records office if guidance is needed.

If you do not withdraw from the course but stop attending (or miss more than four scheduled assignments to be submitted in a row), you can be dropped from this course. If you stay in class but do not submit more than a few assignments, you will receive an "F" for the course. Failure to officially withdraw may result in a failing grade for the course. ### ---- SPRING 2026 SEMESTER: ASSIGNMENT DESCRIPTIONS ----

#### 1. Syllabus & Blackboard Ultra Scavenger Hunt Exercise

This assignment is an **attendance verification activity assigned to be completed** by the Census date. The Syllabus & Blackboard Scavenger Hunt Exercise is done specifically to ensure that you are attending AND participating in this class. It counts as the first attendance check-in of the semester. **It is to get you to read the syllabus and make sure that you are aware of what the expectations of this class are. The Syllabus & Blackboard Scavenger Hunt Exercise is the first assignment and will open at 12am on Tuesday, 20 January 2026. It is worth forty (40) points and will be due by 5pm on Friday, 30 January 2026. This assignment is unique in that there is no extension (no late work will be accepted). Not completing this important assignment will result in being dropped from this course.** However, if you withdraw from class, it is YOUR responsibility to verify that it is completed.

#### 2. Semester Reflection Assignments

There are five (5) semester reflections to be done (one reflection assignment done almost every other week). These assignments allow for the student to provide your feedback – questions, comments, concerns, and suggestions for what we will do in class. The reflection assignments automatically open at 12am on Tuesday, 20 January 2026. But each semester reflection assignment **HAS ITS OWN HARD DEADLINE (STATED IN THE SYLLABUS SCHEDULE)**. Please be careful with these assignments as they are used solely for feedback about the content that we have done for the period that each reflection covers. Do not sleep on these assignments as they tend to be the easiest of assignments on our schedule.

Doing each of these assignments is mandatory and on their own time schedule (they each have their own due dates within a limited amount of time as instructed on our syllabus). **Each reflection assignment is worth fifteen (15) points for a total of 75 points. If you miss submitting an assignment by its original deadline, you have two days from that original deadline to submit it late.** Please check each assignment's instructions for information on all deadlines. **However, this will come with a 3-point deduction off the top for late reflection assignment.** After the assignment deadline extension ends, no late reflection assignment will be accepted - no exceptions.

#### 3. Chapter Question Assignments

There are five (5) regular assignments, each that will focus on a respective chapter. There is a lecture and (in most cases a video) included for the support of the textbook chapter. The videos are a resource to help you – to demystify the more difficult themes in class as well as provide you with some amazing facts on the Texas Government – how and why we have the structure that we do. The videos will help make the topics easier to understand. But there are a couple of the videos that will be the primary focus of an assignment.

There are a few assignments that are attached to bigger videos. Each of these assignments are marked on the Syllabus and in BLACKBOARD ULTRA according to the order of chapters each week. To complete one of these assignments, you will have to watch a video and then complete questions that focus on the video in connection to the chapter featured for that week. Links to these larger videos will be included in their appropriate assignments for easier access. Please make sure to number your answers according to the questions they respond to. Following instructions will ensure that you receive full credit for the assignments prior to grading.

The chapter assignments automatically open at 12am on Tuesday, 20 January 2026. But each chapter assignment **HAS ITS OWN HARD DEADLINE (STATED IN THE SYLLABUS SCHEDULE)**. While it is preferable for you to complete these assignments according to their respective deadlines, the due dates are different and are non-negotiable. So, it is to your benefit and your responsibility to get the assignments done by their respective due dates. **Each chapter assignment is worth fifty-five (55) points for a total of 275 points. If you miss submitting an assignment by its original deadline, you have two days from that original deadline to submit it late.** Please check each assignment's instructions for information on all deadlines. **However, this will come with a 10-point deduction off the top for late chapter assignments. After the assignment extension ends, no late chapter assignments will be accepted - no exceptions.**

#### **4. Discussion Board Assignments**

There are three Discussion Board Assignments for you this semester. Each is worth 60 points for a total of 180 points and will open by 12am on Tuesday, 20 January 2026. They will be about a topic discussed in the textbook that stands out for more discussion. There will either be a newspaper article for you to read or a video to watch, after which students will be asked to give their opinions on what they have read or seen. This first part is worth 30 points (your comment must be at least 100 words in length). You will then have a second part where you will be asked to respond to the comment of one of your classmates. This second part is also worth 30 points (your comment must be at least 50 words in length). But each discussion board assignment **HAS ITS OWN HARD DEADLINE (STATED IN THE SYLLABUS SCHEDULE)**.

Be careful with this assignment as you only get one chance to post an original statement and a follow up to a classmate. This type of an assignment will highlight events that can be connected to themes and topics discussed in our textbook and student learning outcomes identified by the Texas Higher Education Coordinating Board, the Alamo Colleges and TAMUSA. Students are asked to be respectful of the input of your fellow classmates as they wish for their input to also be respected. Each discussion board has its own original deadline. **If you miss submitting an assignment by its original deadline, you have two days from that original deadline to submit it late.** Please check each assignment's instructions for information on all deadlines. **Ten (10) points will be deducted for its late submission, but at least you will still be able to submit this for some credit. No submission will be accepted after this date - no exceptions.**

#### **5. Spring 2026 Semester Final Exam & Preparatory Exercise**

**There will only be one exam this semester – the Final Exam.** It will take the form of the student writing a Constituent letter to an elected official who represents you in one form or another. To do this, we will also have a Final Exam Preparatory Exercise that will serve as the basis for the final exam. This preparatory assignment will allow students to think early about their FINAL EXAM. This preparatory instruction is being released early to allow you to work on it in parts and will be open so that students will have the time necessary to also work on their other assignments while planning for their FINAL EXAM.

***This mini assignment does not ask or demand that you support or oppose anyone.*** What it will do is see what your experience was with the elections process. This is to access and discuss your knowledge about lectures and topics discussed this semester and prioritized by the Texas A& M University - San Antonio student learning outcomes (in part):

- ***Analyze the state and local election process.***
- Identify the rights and responsibilities of citizens.
- Express oneself with precision and clarity, whether orally or in writing.

The Preparatory Exercise will be worth 40 points, while the Final Exam will be worth 100 points. The Preparatory Exercise will have its own separate date. The format of the Final Exam will be in "letter form," of which I will have a sample so that you can see what is expected. ***The instructions will be rolled out to you on Monday, 30 March 2026 to allow you plenty of***

*time to research, ask questions and see what you may want to focus on for your Constituent Letter.* This will allow you the time and space to prepare for the final exam.

***I plan to open the final exam early to allow you enough time to plan for this and your other final exams. It will officially open at 12am on Monday, 4 May 2026 and will close by 12pm on Tuesday, 12 May 2026.*** It will not be timed, so this should allow students to take the final exam without rushing through it. The time will not be extended, so make sure that you are able to take the Final Exam. As this is given at the very end of the semester, there is little room to schedule a makeup opportunity. **It is the student's responsibility to contact the instructor to schedule a make-up (ONLY if you miss the final exam, not re-do it).** Any requests for a make-up to the Final Exam must be accompanied by official documentation (doctor's note, work notice, jury summons, etc....) before any request is confirmed. The make-up will only be open for a limited time – you will lose 20% of the points available for every day it takes you to get the final exam submitted after its original deadline. But no late Final Exam Essay will be allowed after 5pm on Wednesday, 13 May 2026 – no exceptions.

### **FYI: For your information - Resources (lectures & videos)**

The textbook publisher includes extra resources with the textbook and lectures. The extra resources may feature assignments or chapter quizzes designed to assist the student better understand a chapter. You are welcome to complete these extra assignments. But none of them will be graded or included in our grading this semester. **The only assignments you will be expected to complete for a grade are those listed in this syllabus and the Assignments directly listed in BLACKBOARD ULTRA.**

Also, I have also included a resource page for you on BLACKBOARD ULTRA regarding videos to help you better understand the lectures and textbook. Every week, we will focus on a new chapter. Attached to each chapter is a lecture from the original version of the textbook. Even though the textbook was updated, the lectures are the same and are easy to follow. There is also at least an introductory video that describes the information provided in each chapter. Most of the videos are short (no more than 10-15 minutes in length each) and make it easier to understand the content covered by the chapter and lecture.

### **FYI: Extension for late assignments**

**You have a short two-day extension after the original deadline of an assignment expires to submit an assignment late. However, this will come with a (ten) 10-point deduction off the top for late chapter and discussion board assignments and a (three) 3-point deduction for late reflection assignments. *This DOES NOT include extra credit assignments as they will not receive an extension to submit.*** Please adhere to the instructions listed in each assignment. Submit all assignments in a Word document or use the text response box... No assignment submission will ever be received by email. Any missing weekly and reflection assignments will automatically be given a "0".

### **General Expectations**

**You are expected to check into our class BLACKBOARD ULTRA site several times each week of the semester (I would say every day), to complete the weekly readings/lectures and their assignments (including the final exam) by the dates listed in our schedule in the syllabus.** Instructions for the assignments are posted both in the syllabus and in each of the assignments, respectively. The assignments for this class can be found on BLACKBOARD ULTRA under the assignment prompt on the main navigation list.

**No student can pass the course without completing ALL assignments and exams.** One's inability to manage their time or adequate plan for class does not constitute an emergency for me. Do not wait to let me know if there is an issue that can

hinder your participation in our class. Waiting to contact me after there is an issue does not help you – instead, it takes away necessary time for you to get the assistance that you need to complete the assignments.

Please plan accordingly as there is at least one assignment a week. Let me know if there are any issues so that we can see what adjustments can be made to help. I would like to help as much as I can. But communication must flow in both directions. Please email me so that I can provide help with your assignments or on other issues. Waiting until the last minute to submit your assignment or ask for help after a deadline takes away your ability to get help and adjust when possible.

### **Respect for each other**

Please use respectful language in all correspondence with me, in any class discussion posts as well as assignments. There is **a zero-tolerance policy** in my class regarding racism, sexism, homophobia, xenophobia, or any other highly offensive or violent rhetoric. As our class is about the Texas government, I expect the conversation to be spicy... especially as there is another busy election season upon us. HOWEVER, everyone is expected to give respect for others as you want respect from others.

As your instructor, I will respect the dignity and essential worth of all individuals; will promote a culture of respect for the TAMUSA community; respect the privacy, property, and freedom of others; reject bigotry, discrimination, violence, or intimidation of any kind; practice personal and academic integrity and expect it of others; and promote the diversity of opinions, ideas, and backgrounds, which is the lifeblood of this university. I expect the same of each student in the class for themselves and your classmates.

7. **CLASS COMMUNICATION:** You may be emailed throughout the week with information regarding class related topics like the assignments and announcements, as well as the Zoom information so that students can drop in to ask questions or discuss issues with the assignments. I am also reachable by email and BLACKBOARD ULTRA messages/chat daily Monday through Friday. Any email sent to me after 8:00pm will not be answered until the next day after I have completed my classes scheduled. On the weekends, On the weekend, it may take up to 48 hours to respond after I have received your email.
8. **THE SYLLABUS:** Keep up with the syllabus and the dates of each assignment. Make a copy of it and keep it with you, place the dates of each assignment on your calendar. But please be advised: I will not answer emails regarding what a student may have missed if they were not able to participate in an assignment. Our syllabus and your Blackboard include a schedule with every assignment and instructions.
9. **FOLLOW THE SYLLABUS SCHEDULE:** Complete and submit all assignments in BLACKBOARD ULTRA on time as instructed. Each assignment has its OWN HARD DEADLINE (check the assignment's instructions and syllabus schedule for this information). **You have a short two-day extension after the original deadline of an assignment expires to submit an assignment late. However, this will come with a (ten) 10-point deduction off the top for late chapter and discussion board assignments and a (three) 3-point deduction for late reflection assignments. This DOES NOT include extra credit assignments as they will not receive an extension to submit.**
10. **SUBMITTING ASSIGNMENTS:** Please adhere to the instructions listed in each assignment. Submit all assignments in a Word document or use the text response box... never in any other form (like Google Docs) UNLESS otherwise instructed No assignment submission will ever be received by email. Any missing weekly and reflection assignments will automatically be given a “0”.
11. **EXTRA CREDIT:** There may be extra credit offered during the semester but details of how it may be used will be determined at the instructor's sole discretion. DO NOT depend on the offering of extra credit to help build your

grade. Any points of extra credit earned will be placed in the general pool of points needed to pass the course. Your adherence to our syllabus and assignment completion should be practiced throughout the semester.

12. **ADVOCATING FOR YOURSELF: It is okay to advocate for yourself. I want to assist you as much as I can, but it only goes so far – students will have to meet me halfway. Do the work and do not hesitate to let me know when you need help.** It ties my hands if you wait too long to ask for help as a deadline passes (I know that we all procrastinate but doing so for each assignment may eat away time needed to get assistance on an assignment).
13. **Communication is key and must FLOW BOTH WAYS.** This is not for me to get up into your business... rather an opportunity for us to get ahead of a concern and allow me the chance to help you if I can. Let me know if something happens that may hinder your ability to participate for this class (assistance done on a case-by-case basis).
14. **Respect for each other is expected.** Inappropriate behavior and disrespect are not welcomed. It will result in an immediate end to the conversation and/or removal from class. I ask for all students to respect each other's opinions. It is okay if we disagree, but we can do so respectfully. If there is a point of disagreement, please refrain from mocking each other. Let me know so that I can address it. Please remember that as you wish for respect to make your comment you must also respect that right of others.
15. **Do not wait until the end of the semester to worry about your grade. Adherence to the syllabus for all assignments should be practiced during the entire semester. Every point counts!!** The grade you are given is the grade you will have earned by the work you have done throughout the semester. I do not grade by curves, and I will not add points that have not been earned to boost a grade. I will not haggle over grades or tolerate frivolous requests for re-grades (e.g., requests to boost the grade beyond the work you as the student has already submitted for a grade). It is up to you to maximize whatever assignment/extra credit opportunities you receive. **Keeping up with ALL assignments and caring about YOUR grade should be practiced throughout the semester. Care enough about your grade to put your best effort into EVERY ASSIGNMENT...**not just at the end of the semester.
16. **FOLLOW THE INSTRUCTIONS OF EACH ASSIGNMENT: Ask for clarification BEFORE submitting an assignment.** Read the instructions for each assignment. Please make sure to number your answers according to the questions they respond to. Answer a question in its entirety. **Do not give a partial response to a question or half do an assignment and expect to receive full credit.** Partial responses/work will result in partial credit. Follow the chosen format and instructions of each assignment. For instance - if the assignment is a chapter assignment with chapter questions, then make sure that each response is numbered according to the assignment. DO NOT submit your answers to short answer questions (chapter assignments) in bullet points or one big paragraph/in essay form UNLESS the assignment calls for it.

Doing your answers in one big paragraph or unnecessarily placing them in essay form: placing all of your answers in an essay; or supplying your answers without the numbers your answers respectively respond to **DOES NOT follow the instructions of the assignment. I will not dissect your submission to make sure that you have answered each question. I will automatically deduct half of the points that assignment is worth OFF THE TOP (before it is graded for content). CONSIDER THIS YOUR WARNING...** It is unfair to other students who followed the instructions to allow a student's incorrect submission to receive full points...

**The Six-Drop Rule:** Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Texas A&M University-San Antonio faculty are committed to providing a safe learning environment for all students and for the university as a whole. **Pregnant/Parenting Students:** Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to:

1. take a leave of absence or withdraw from their degree or certificate program
2. limit the student's studies
3. participate in an alternative program
4. change the student's major, degree, or certificate program
5. refrain from joining or cease participating in any course, activity, or program at the University.

The university will provide reasonable accommodation to pregnant students as would be provided to a student with a temporary medical condition that is related to the health and safety of the student and the student's unborn child. These could include maintaining a safe distance from substances, areas, and activities known to be hazardous to pregnant individuals and their unborn child; excused absences because of illness or medical appointments; modified due dates for assignments; rescheduled tests/exams; taking a leave of absence; and being provided access to instructional materials and video recordings of lectures for excused absences, if these would be provided to any other student with an excused absence. Texas A&M-San Antonio has also designated the Title IX Coordinator as the liaison officer for current or incoming students who are the parent or guardian of a child younger than 18 years of age. The Title IX Coordinator can provide students with information regarding support services and other resources. Young Jaguars can support parenting students with daycare if students meet this criterion:

1. must be enrolled in classes at Texas A&M-San Antonio in the current semester
2. must be Pell eligible or a single parent
3. child(ren) must be aged 3 to 12-years-old,
4. child(ren) must be enrolled in Pre-K-3 through 6th grade.

**Students' Rights and Responsibilities:** The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country

### Students' Rights

1. A student shall have the right to participate in a free exchange of ideas, and there shall be no University rule or administrative rule that in any way abridges the rights of freedom of speech, expression, petition, and peaceful assembly as set forth in the U.S. Constitution.
2. Each student shall have the right to participate in all areas and activities of the University, free from any form of discrimination, including harassment, on the basis of race, color, national or ethnic origin, religion, sex, disability, age, and pregnancy/parenting or veteran status in accordance with applicable federal and state laws.
3. A student has the right to personal privacy except as otherwise provided by law, and this will be observed by students and University authorities alike.
4. Each student subject to disciplinary action arising from violations of university students' rules shall be assured a fundamentally fair process.

**Students' Responsibilities:** A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.

1. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, Student Code of Conduct, on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
2. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
3. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning.
4. A student has the responsibility to check their university email for any updates or official university notification.

We expect that students will behave in a manner that is dignified, respectful, and courteous to all people, regardless of sex, ethnic/racial origin, religious background, or disability. Conduct that infringes on the rights of another individual will not be tolerated.

Students are expected to exhibit a high level of honesty and integrity in their pursuit of higher education. Students engaging in an act that violates the standards of academic integrity will find themselves facing academic and/or disciplinary sanctions. Academic misconduct is any act, or attempt, which gives an unfair advantage to the student.

Additionally, any behavior specifically prohibited by a faculty member in the course syllabus or class discussion may be considered as academic misconduct.
