Catalog Course Description: This course explores the growing challenges of securing sensitive data networks, mobile devices and applications with different privacy controls to defend against malicious acts. Also, this course addresses new trends in computer science and how machine learning and anti-malware defenses can respond to threats, and protect networks, infrastructure and users.

Prerequisite: Department approval

Course Objectives: The objective of this course is to expose students to the concepts behind wireless/mobile technologies and their relevant security issues (vulnerabilities/defenses) from both a theoretical and practical perspective.

Student Outcomes: Upon completion of this course, students will have the ability to:

- 1) Understand the fundamental concepts of Intrusion detection systems (IDS).
- 2) Analyze the evolution of IDS technologies and their applications to emerging threat landscapes.
- 3) Perform network analysis and implement a security protocol/system for detecting intrusions.

- 4) Demonstrate proficiency of security issues related to Machine learning threats.
- 5) Analyze threat models/exploitation strategies in current landscape from an attacker's perspective to securely design IDS.

Required Materials:

- **Textbook:** There is no fixed textbook for this course. Lecture slides and relevant research work/reference material links will be posted on Blackboard Ultra.
- **Blackboard:** Connect to <http://tamusa.blackboard.com>. You will have lecture notes and other supplementary materials in Blackboard. All class communications will be through Blackboard and students should monitor this several times a day.
- **Time:** You are expected to spend 4-8 hours per week for the course. This might vary based on the student's background and during exams/assignment submissions.

Course Requirements every student must fulfill in order to succeed in course:

1. Students should check all course components/tabs of Blackboard to be up-to date with relevant class information.
2. Active participation with the Instructor during in-class sessions is highly encouraged.
 - a. *Note: I always send a response to your email.
3. For all classwork, exams, etc., if a student is completing it off-campus, then they are responsible for the availability of internet connectivity. Extensions will **not** be granted for lack of availability of internet connections, unless you have prior written approval from the Instructor.

Mid-term Exam: There will be a mandatory Midterm Exam (refer to schedule and in-class discussions). Being absent for an exam will result in a grade of zero for that exam and may result in failure of the course. The exams will consist of conceptual questions, and open-ended (case-study style) questions. Exams will be based on lecture notes and class discussion. Quizzes (if any) will follow a similar style as exams, with relevant materials for each quiz discussed during class discussions.

Class Participation: Students are expected to actively participate in regular classes and class discussions.

Assignments/Project: There will be multiple assignments and a semester long project during

the course. All submission formats, details will be posted on Blackboard. Students are expected to pay attention to the submission instructions, points may be taken off if the instructions are not followed. Please be advised that the Project requires a mandatory, face-face final presentation (dates will be assigned later).

Make up presentation policy:

By default, there are no make-up options for this course. Please contact the Instructor for more information.

Late Submission Policy:

Late submissions will be accepted, but a penalty will apply as follows:

All submissions will incur a 0.5% penalty for each hour for the first 24 hours after the mentioned final submission deadline, and 20% for each subsequent day, until 0%. Students are advised to pay extra attention to Blackboard for the submission dates. There will be no exceptions to this rule.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
