### Catalog Course Description:

This course provides an examination of the source and content of basic accounting theory from the point of view of the FASB Statements of Financial Accounting Concepts and Statements of Financial Accounting Standards. Special emphasis is placed on student understanding of complex accounting processes. Emphasis on the creation and use of general journal entries, end of period adjusting entries, completion of the accounting cycle and production of income statements, changes in owners' equity, statements of cash flows, and balance sheets. Special attention is paid to issues of the measurement and timing of revenues and expenses. This course may be completed by passing the Financial Accounting CLEP test with a minimum score of 80%. TSI Restriction(s): Reading, Math, Writing

### Course Objectives:

The objectives of this course have the purpose of providing students with a firm understanding of financial accounting, Generally Accepted Accounting Principles, and accounting procedures as they relate to the production of financial statements.

**Prerequisites:** ACCT 2301 and ACCT 2302, or equivalent.

**Restrictions:** Graduate level students may not enroll.

### STUDENT LEARNING OUTCOMES:

- 1) At the conclusion of this course, you will demonstrate a conceptual understanding of:
  - a) The Balance Sheet and Financial Disclosures
  - b) The Income Statement, Comprehensive Income, and the Statement of Cash Flows
  - c) Time Value of Money Concepts
- 2) At the conclusion of this course, you will be able to develop accounting entries, journalize the accounting entries in the appropriate journal, post the accounting entries into the appropriate subsidiary ledger accounts or general

ledger accounts, close the temporary accounts to the balance sheet, and develop financial statements from the formal accounting records.

### Final Examination

The final examination is comprehensive of the entire course. The final examination accounts for **40%** of the overall grade. The final examination will be administered online through Connect. You will receive notice of the availability of the final exam by Blackboard Announcement and email. Each question will allow for 6 minutes to answer. Extensions will **not** be granted for lack of availability of internet connections. You are strongly discouraged from using any wireless connection for completion of any homework, quiz, examination, or final examination. It is the student's responsibility to have an adequate connection to complete these.

### Examinations

There will be three examinations administered online through Connect. Together, these three tests account for **35%** of your grade. Each examination is limited in time, and you will have only one opportunity to obtain the highest grade you can. You will receive notice of the availability of the examinations by Blackboard Announcement and email. Each question will allow for 6 minutes to answer. Extensions will **not** be granted for lack of availability of internet connections. You are strongly discouraged from using any wireless connection for completion of any homework, quiz, examination, or final examination. It is the student's responsibility to have an adequate connection to complete these.

### Chapter Quizzes

Chapter quizzes will be administered online through Connect. You will receive notice of the availability of the chapter quizzes by Blackboard Announcement and email. Each quiz will consist of ten multiple choice questions. Each question will allow for 6 minutes to answer. Extensions will **not** be granted for lack of availability of internet connections. Together, chapter quizzes account for **20%** of your grade. Each chapter quiz will be limited in time, and you will have two quizzes per chapter. You will have one opportunity to complete each quiz. You are strongly discouraged from using any wireless connection for completion of any homework or quiz assignment. It is the student's responsibility to have an adequate connection to complete these.

### Homework Assignments:

Homework problems will be administered online through Connect. Notice of Homework assignments will be given online by Blackboard Announcement and email. Each assignment will consist of ten to fifteen multiple choice questions. You have as many as twenty attempts on each homework assignment to earn the highest grade you can.

The grade for the homework assignments is based on completion and accuracy. A total of **5%** of your grade is based on your homework assignments. Extensions will not be granted for lack of availability of internet connections. You are strongly discouraged from using any wireless connection for completion of any homework or quiz, assignment. It is the student's responsibility to have an adequate connection to complete these.

### **Make up and Late Assignment/exam/quiz policy:**

#### **Make up and Late Assignment/exam/quiz/final exam policy:**

As a general rule, make-ups or late submissions will **NOT** be offered or accepted for any missed assignments/exams/quizzes/final exam. Late submissions or make-ups may be accepted/administered only in extra-ordinary circumstances such as an excused official university activity, a severe illness, or a dire emergency. However, you must provide comprehensive documentation either before or within a few days of the missed assignment/quiz/exam. 

**Students' Rights and Responsibilities:** The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country.

### **Students' Rights**

1. A student shall have the right to participate in a free exchange of ideas, and there shall be no University rule or administrative rule that in any way abridges the rights of freedom of speech, expression, petition and peaceful assembly as set forth in the U.S. Constitution.
2. Each student shall have the right to participate in all areas and activities of the University, free from any form of discrimination, including harassment, on the basis of race, color, national or ethnic origin, religion, sex, disability, age, and pregnancy/parenting or veteran status in accordance with applicable federal and state laws.
3. A student has the right to personal privacy except as otherwise provided by law, and this will be observed by students and University authorities alike.
4. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

## **Students' Responsibilities**

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, [Student Code of Conduct](#), on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
4. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning.
5. A student has the responsibility to check their university email for any updates or official university notifications.

We expect that students will behave in a manner that is dignified, respectful, and courteous to all people, regardless of sex, ethnic/racial origin, religious background, or disability. Conduct that infringes on the rights of another individual will not be tolerated.

Students are expected to exhibit a high level of honesty and integrity in their pursuit of higher education. Students engaging in an act that violates the standards of academic integrity will find themselves facing academic and/or disciplinary sanctions. Academic misconduct is any act, or attempt, which gives an unfair advantage to the student. Additionally, any behavior specifically prohibited by a faculty member in the course syllabus or class discussion may be considered as academic misconduct.
