## About the Course

### Course Description

This introduction to the visual arts is designed for the general student, as an exploration of purposes and processes in the visual arts including evaluation of selected works.

This course presents a survey of the visual arts, including artistic media and techniques, and art history. Students will also explore visual principles and elements through hands-on activities.

## Course Structure

In Art Appreciation, we will be looking at the basic principles of design, medium, history, and context which animate contemporary and historic art. This will serve as an introduction to the art world and empower students to be critical viewers.

We will complete three lesson units this semester. Each lesson unit will last three weeks. In each unit you will complete the following tasks:

1. Complete assigned reading quizzes from the course textbook.
2. Participate in and complete an art project related to the unit's assigned reading.

At the end of the semester students will also complete two major assignments.

1. One assignment will be a short analysis and interpretation-based assignment.
2. The other will be a final creative project that tasks the student with generating their own work of art.

## Written Assignments 12.5 %

Each unit has one written assignment which asks questions of the student depending on the subject at hand. These assignments will be done independently so the student can brainstorm the information presented.

## Discussions 32.5%

Since this course is online and asynchronous, It is important we share the information we have learned with each other. Each section has several discussions for you to interact and brainstorm together.

## Art Projects 15%

There are two experiment art projects which are less about seeing your artistic abilities and more about how to arrive at a solution to a visual problem. Both of these assignments are framed as discussions so you can share the final product with each other and see what conclusions you arrived to individually.

## Major Projects 40%

The major projects consist of two different projects. One is "Art Watching" which invites a student to look at art in the real world. The second is the Art Documentary Analysis which revolves around writing a 3 page paper that discusses one of three documentaries listed alongside this section.
