Fundamentals of Evolution Lab -BIOL 3105 – 600

Asynchronous

Course Description and Prerequisites

A laboratory-based exploration of evolutionary theory, integrating conceptual frameworks with hands-on investigation. Students will examine case-studies of specific organismal evolutionary events while conducting simulations and analyses to understand evolutionary mechanisms. Topics include microevolutionary processes (e.g., genetic drift, natural selection) and macroevolutionary patterns (e.g., speciation, adaptation, biogeography). Laboratory exercises emphasize tree-building, population genetics, natural selection, and interpretation of evolutionary relationships using real-world datasets. Pre-requisites: BIOL 2411.

Course Objectives

- Understand and Apply Evolutionary Theory. Gain a deeper understanding of Darwin's Theory of Evolution by Natural Selection and use it to explain patterns observed in the natural world and the history of life.
- Evaluate Evidence and Mechanisms. Critically evaluate evidence supporting evolutionary change and analyze key mechanisms, including mutation, natural selection, adaptation, speciation, population genetics, molecular evolution and phylogenetic systematics.
- Engage in Hands-on Investigation. Apply evolutionary concepts through laboratory-based activities, including analyzing genetic variation, reconstructing phylogenies, simulating evolutionary processes, and evaluating fossil and molecular evidence.

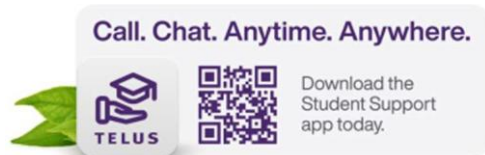
University Email Policy and Course Communications: All correspondence between professors and students must occur via University email accounts. Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

The Six-Drop Rule: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. Students' Rights
