- Book fee was assessed – you should have access on the first day of class through the online BryteWave system. *Do not pay again if you hit a paywall!*
- You may also purchase a loose-leaf copy at a special rate from the publisher. This is a great option if you know you will need a physical copy of the text.
- Always bring a calculator (one that has a natural log key [ln]) to class, especially lab. This makes you a participant, not simply an observer, when calculations are covered in class. Calculators with RNG (random number generator) functions are especially useful in lab. **Note: cell phones & affiliated apps are NOT allowed on exams.**

**Blackboard:** This is where you will go for lecture notes, some assignment submission links, grades, and weekly announcements. Power-point/PDF versions of lectures will be posted on Blackboard; Announcements regarding lectures or labs may be posted on Blackboard; Grades for individual assignments/labs etc. will be posted on Blackboard as we go along.

**Recommended (HIGHLY) Material:** You will be required to bring an **882-E scantron** for each of your exams (4 total; see schedule) and **a pencil**. You can purchase a scantron packet from the bookstore.



You are also **HIGHLY** encouraged to work off of a **computer or laptop with audio/microphone** as a phone does not have the capacity to run some of the virtual material. If you need a computer or wi-fi, please contact IT directly for assistance. IT contact information can be found in the Table of Contents in Blackboard as well as the University website. Furthermore, computer labs on campus are open and available to you! Finally, it is up to the student to have a **stable internet/browser connection** when conducting any online coursework.

### Catalog Description and Prerequisites:

A study of the fundamental process of the animal systems. This course will cover physiological processes of animals from the molecular to organismal and population levels. Concurrent laboratory participation is required.



*Note: Modern Biology is an integrative discipline, incorporating elements of Mathematics, Chemistry, Computer Science, and Writing. We expect that you have at least a basic understanding of each of these elements.*

### Learning Objectives:

This course will familiarize students with the basic principles of the integrated science of animal physiology, i.e. the dynamics of physiological processes as influenced by interrelationships between organisms and their environment, including interactions with other organisms that leads to a diversity in form and function on earth.

#### Specifically:

- Understand the physiological mechanisms that explain how **animals** work and function.
- Explore the diversity of physiological adaptations in animals.
- Integrate the chemical, molecular and cellular components of animal physiology into body function.
- Understand how cells, organs, and organ systems function in a variety of **invertebrates** and **vertebrates**.
- Students will be able to apply the scientific method to various scientific questions by formulating testable hypotheses, designing experiments, collecting data, statistically analyzing and interpreting data, and making appropriate conclusions based on those data,
- Students will demonstrate the ability to communicate scientific information through oral and written formats,
- Students will be able to use and understand the primary scientific literature of science,
- Students will gain a familiarity with core concepts of biology from genetics, evolution, and a diversity of biotic systems over the course of the semester, and
- Student will gain experience in using current technologies associated with the biological sciences.

### Course Design

This course combines a lecture and laboratory section. These two sections will have different weight in your final grade for the course. The lecture section will be worth 75% of your course grade. The laboratory section will be worth 25% of your grade.

### Lecture

You are expected to attend lecture and take notes for the material discussed in class. Power-point/PDF lecture notes may be available after lecture on Blackboard. Provided slides are meant as a guide, not as a replacement for attending lecture and will encourage some note-taking.

### GRADING and METHODS OF ASSESSMENT

1. Competencies will be demonstrated on assignments, quizzes, class/group participation, and exams. Exams will have a combination of essay, listing, multiple choice, and true/false questions. All types may not be included on each exam.
2. A student must master 70% of the competencies in order to receive credit for the course. A student demonstrating 90% or more knowledge of all competencies will receive an A in the course.
3. All assignment, quiz, and exam submissions will be **face-to-face**.
4. All methods of assessment will be graded on a point system.
5. All assignments, quizzes, class/group discussions, and exams are scheduled on the *tentative* syllabus schedule



and Blackboard Calendar.

6. Take-home assignments will be handed out during class time and will not be emailed if absent; therefore, *be sure to come to class!*
7. You may turn course work in ahead of the deadline, but if you miss the deadline, you will be assigned a zero for the particular course work. I DO NOT ACCEPT LATE WORK.

**Grading:**

Throughout the semester you will be informed of your grade standing. Grades will be posted on Blackboard.

I will consider scaling up from a B to an A if you have earned an **89.7 and** you have great attendance.  
I will *not* scale up from a B to an A (regardless of your attendance) if you have earned an 89.1%, that is a B through and through.

**\*\*HINTS FOR SUCCESS.** Complete assignments and submit them in on time. Do not wait until the night before to study for exam or complete assignment. All assessments are provided with plenty of completion time.

**Lecture Exams (Face-to-Face):**

1. You will be given **three (3) Lecture Exams & a Cumulative Final Exam.**
2. Your Lecture Exams will consist of approximately 40-50 questions in the format stated in Grading Scheme #1 above.
  - Exams will be **given during the scheduled class time**; Feedback will be limited and provided during office hours or by appointment.
  - Exams must be taken on the scheduled class date/time in syllabus & Blackboard.
3. Your Cumulative Final Exam contains material from the entire semester. This exam must be taken (it cannot be dropped or replaced).
  - Your final exam will be in a format similar to your lecture exams.
  - Your final exam will consist of 100 questions and worth 200 points.
  - Final Exam must be taken by the due date in the syllabus and University Final Exam Calendar and Blackboard during the scheduled time.
4. Exams must be taken when scheduled.
  - You may make up an exam **only if**
    - you contact me within **one day (24-hours)** of the scheduled exam
    - your absence is one approved by college policies (illness, death in the family, other immediate-family emergencies). **Documentation will be required.**
    - Again – **if I do not hear from you within 24 hours of the scheduled exam, you have forfeited the right to make up the exam.**



**Take-Home Assignments/Activities:** (5 at 20 points each = 100 points total)

- Points will vary throughout the semester but may include homework questions to emphasize the topics, writing comprehensive essays on assigned articles, literature research on current topics of interest related to the course, and class discussion/debates of current topics.
- Assignments/Activities will be handed out during class time and will not be emailed if absent; therefore, be sure to come to class!
- Assignments/Activities cannot be made up; therefore, please check the schedule and Blackboard.

**Checkpoint Quizzes/Activities (during class time):** 10 quizzes/activities (10 points each = 100 points total)

- Checkpoint quizzes are scheduled throughout the semester. These quizzes will *vary in format* but will be used to *assess progress* in course concepts.
- Checkpoint quizzes cannot be made up; therefore, please check the schedule and Blackboard.

Participation in Class Discussions: During class, I will note your contributions to our conversations on weekly topics. You do not have to comment every class period, but you should make multiple comments throughout the semester. *Occasionally*, I may decide to take attendance/note participation for some extra credit points.

**Attendance / Participation:**

**This is a face-to-face course; therefore, actually coming to class is important.** I will randomly take attendance during some lecture days, which can consist of roll call, activity participation, question of the day submissions, etc. Therefore, if you miss class and attendance is taken, you have forfeited any potential attendance points for that day unless you provide a university-excused absence documentation (per the syllabus). *If you also miss class, you will be responsible for obtaining missed information from your classmates and/or reading the textbook.*

**Makeup Policies:**

Due to the nature of this course and the fact that exams, quizzes, and homework/assignments are given plenty notice and/or are available for more than one week, make-up opportunities will only be allowed for:

- a. Hospitalization (evidence required),
- b. Hospitalization of an immediate family for which you are the primary caretaker (evidence required), or
- c. Incapacitating illness, such as COVID (evidence required).

If any of the above have prevented you turning in exams, quizzes, or assignment by the due date, you must contact me within 24 hours of the due date. **Due dates for anything assigned will be strictly enforced.**

**Blackboard and Course Communication**

All grades and assignments will be posted and accessible through the course's Blackboard site. Students must log-in regularly to both the Blackboard site and to their TAMU-SA email account to keep updated on information related to the class. Each student MUST have an active TAMU-SA email account. This will be the email address that is used for any communication between me and you. Students who e-mail me Monday-Thursday ordinarily can expect a response within 48 hours. Students who e-mail Friday-Sunday ordinarily can expect a response by 9:00 PM on Monday.

**Use of Generative AI Permitted Under Some Circumstances or With Explicit Permission**

There are situations and contexts within this course where you may be asked to use artificial intelligence (AI) tools to explore how they can be used. Outside of those circumstances, you should not use AI tools to generate content (text, video, audio, images) that will end up in any student work (assignments, activities, discussion responses,



etc.) that is part of your evaluation in this course. Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

## STUDENT OBLIGATIONS

1. **Attendance:** Regular and punctual attendance in all classes and laboratories, day and evening, is required. Students who are absent for any reason should always consult with their instructors prior to absence (if possible). Both tardiness and early departure from class may be considered forms of absenteeism. A student may be dropped if there are excessive absences. 7. **Assessments:** All chapter homework, quizzes, and assignments are due Sunday by midnight on the Blackboard website. You are encouraged to get ahead on assignments. Once the deadline has passed, your score will be zero with no make-up opportunity if it has not been completed, unless your instructor states differently. Blackboard will have a calendar displaying when all assignments and exams are due. It is the student's responsibility to frequently check this calendar. Finally, it is up to the student to have a stable internet/browser connection when conducting online assignments. Feel free to utilize the campus or contact IT for assistance.
8. **Grades:** All grades are final at the end of the semester. If there is an issue, please make an appointment with me and be prepared to defend your case (i.e. bring ALL assignments, etc.).

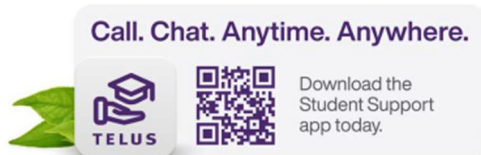

The Six-Drop Rule: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Statement of Harassment and Discrimination: Texas A&M University-San Antonio is committed to the fundamental principles of academic freedom, equal opportunity, and human dignity. Texas A&M University-San Antonio faculty are committed to providing a safe learning environment for all students and for the university as a whole. Pregnant/Parenting Students: Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable accommodations to pregnant students as would be provided to a student with a temporary medical condition that are related to the health and safety of the student and the student's unborn child. These could include maintaining a safe distance from substances, areas, and activities known to be hazardous to pregnant individuals and their unborn child; excused absences because of illness or medical appointments; modified due dates for assignments; rescheduled tests/exams; taking a leave of absence; and being provided access to instructional materials and video recordings of lectures for excused absences, if these would be provided to any other student with an excused absence. Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country.

#### *Students' Rights*

A student shall have the right to participate in a free exchange of ideas, and there shall be no University rule or administrative rule that in any way abridges the rights of freedom of speech, expression, petition and peaceful assembly as set forth in the U.S. Constitution. Each student shall have the right to participate in all areas and activities of the University, free from any form of discrimination, including harassment, on the basis of race, color, national or ethnic origin, religion, sex, disability, age, and pregnancy/parenting or veteran status in accordance with applicable federal and state laws. A student has the right to personal privacy except as otherwise provided by law, and this will be observed by students and University authorities alike. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

#### *Students' Responsibilities*

A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, [Student Code of Conduct](#), on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning. A student has the responsibility to check their university email for any updates or official university notifications.

We expect that students will behave in a manner that is dignified, respectful, and courteous to all people, regardless of sex, ethnic/racial origin, religious background, or disability. Conduct that infringes on the rights of another individual will not be tolerated. Students are expected to exhibit a high level of honesty and integrity in their pursuit of higher education. Students engaging in an act that violates the standards of academic integrity will find themselves facing academic and/or disciplinary sanctions. Academic misconduct is any act, or attempt, which gives an unfair advantage to the student. Additionally, any behavior specifically prohibited by a faculty member in the course syllabus or class discussion may b
