Course objective: In Genetics lab, students will perform assignments and experiments that reinforce and enhance the material learned in lecture. Students will learn skills and knowledge currently utilized in research laboratories. Additionally, students will write a short scientific report to learn and practice the process of scientific writing.

Deadlines: Late papers and worksheets may not be accepted or may be subject to a grade reduction of 10% per day late. The penalty for late work will be determined at the instructor's discretion.

Excel spreadsheet and lab report: You will be carrying out a multi week fly cross to generate data that you will use to analyse linkage between the yellow and white genes in *Drosophila*. The first part of the assignment will be to turn these data into a graph and the second part will be to carry out a Chi-square analysis of these data and write this up independently (not as pairs) as a short formal lab report.

In-lab & post-lab assignments: Students will frequently be asked to fill out worksheets and answer questions during and after labs. In general, assignments are due by the start of your next scheduled lab session.

NOTE: although you will be collaborating as pairs due to the way in person labs are arranged, all work you submit should be your own. Copying of assignments between lab

partners or other students will be treated as plagiarism. This is especially true of the fly lab report.

Communication: All students are expected to access Blackboard for updates on the course and to access course materials. I am available if you need clarification on materials and assignments in this course. Email is also an excellent way to get in touch with me.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

The Six-Drop Rule

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
