

Graduate Thesis – 11532 - BIOL 5306A – 001**M-F: SciTech 342****Meeting Times: Variable**

Course Description: This course enables dedicated hours for proposal writing and research activities, including written and oral communication, research design, field and/or lab work and data analyses, that will lead to a written thesis. The preparation and defense of a master's thesis is the culminating experience in the M.S. in Biology Program. Students are expected to work with a high level of self-motivation. Successful students exercise initiative and exhibit strong communication skills in working with their advisors and committee members. This course requires individual effort that is overseen by the Thesis Advisor/Committee Chair. Weekly or bi-weekly meetings will be held to discuss progress and review submitted documents. Once the research, necessary analysis, and/or results compilation are completed, the thesis proposal or thesis chapter(s) will be written and revised iteratively between the student and thesis advisor until the document(s) is/are ready for submission to the Thesis Committee. If the committee agrees, then research activities should commence/continue (e.g., with an approved thesis proposal) or a thesis Defense will be held (Note: Thesis should be submitted to the committee no later than 2 weeks prior to the proposed thesis defense date).

Prerequisites: Graduate status in MS Biology, thesis track, and establishment of a graduate advisory committee.

Recommendation: To repeat the course (>3 CR), students should have an approved Thesis Proposal on record. The course may be repeated up to 3 times.

Required: Instructor Approval.

Course Objectives

- Identify different styles and qualities of writing, critically evaluate written work, and improve writing skills
- Conduct a literature review to establish the topic background, methods, and research objectives/questions/hypothesis.
- Design and execute research project that demonstrates critical thinking and use of knowledge and skills for biological data analyses, interpretation, and communication.
- Describe thesis research clearly and succinctly, in written and oral forms, to faculty, mentors, and potential sponsors.

COURSE POLICIES

Weekly or bi-weekly individual meetings will be held to discuss submitted deliverables and revise the work plan if needed. Completion of this course is determined when each member of the Thesis Committee approves the proposal and/or thesis. After proposal or thesis defense, the Thesis Proposal and/or Thesis Approval form(s) is/are signed after successful completion of an oral defense.

Blackboard and Course Communication: All grades will be posted and accessible through the course's Blackboard site. Students must log in regularly to both the Blackboard site and to their TAMUSA email account to keep updated on information or changes related to the class. Each student **MUST** have an active TAMUSA e-mail account. This will be the e-mail address that is used for any communication between you and your instructor. Students who e-mail the instructor Monday-Thursday ordinarily can expect a response within 24 hours. Students who e-mail Friday-Sunday ordinarily can expect a response by Monday morning. The preferred method of communication will always be e-mail or making an appointment (in person or virtually).

Week 1	Meet with an advisor and prepare writing and work schedule.
Week 2–9	Write full thesis proposal draft via iterative sections submission to advisor for review. Collect preliminary data, if applicable.
Week 10	Prepare the final revision of the thesis proposal draft.
Week 11	Submit proposal draft to committee.
Week 12–13	Proposal Defense.
Week 14	Final Revision and Thesis Proposal Approval Form signed.
Week 15–16	Submit the Thesis Approval Form and Thesis Proposal to the Graduate Studies Office (graduate.studies@tamusa.edu).



Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor’s permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio’s standards of academic integrity.
