## WHAT THIS CLASS ACTUALLY IS

Catalog Description - Designed as the capstone course for Communications majors. By working on a capstone project that draws on prior coursework, students not only utilize their critical thinking skills in synthesizing previous coursework, but also extend and develop their own original ideas. Prerequisites: COMM 3341 and all 3000-level and below required COMM coursework.

Course Objectives – By the end of this course, students should be able to:

1. Design appropriate sampling strategies for communication research
2. Select and apply appropriate statistical tests for research questions
3. Interpret and present quantitative research results
4. Develop a complete research proposal including methodology and analysis plan
5. Present research findings effectively to academic and professional audiences

## COURSE DESCRIPTION

Building on the foundation established in COMM 3341 (Research Methods), this course focuses on data analysis, interpretation, and presentation of communication research. Students will develop a complete research proposal including sampling strategy, data analysis plan, and presentation of anticipated results.

## HOW THIS CLASS IS GOING TO WORK

This course combines theoretical understanding with practical application. Each week includes:

- Discussion of statistical concepts and their application
- Hands-on practice with data analysis
- Workshop time for developing research proposals

As you can see in the breakdown below, most of your grade this semester will come from the development and presentation of a research proposal.

As ever, I would advise you very strongly to prioritize your various commitments so that you can submit all of your assigned work on time. Zeroes have a destructive impact on your overall grade.

## CLASS POLICIES

**Attendance:** Attendance is mandatory for this class and all others in the Communication program. If you do miss a class, it is your responsibility to check Blackboard, find out about any assignments/due dates/handouts/announcements that were covered in the class(es) you missed, and make up any work you missed.

Absences: Missing the equivalent of two weeks of class due to unexcused absences will reduce your final grade for the course by one full letter grade. Missing the equivalent of three weeks of class due to unexcused absences means that you cannot pass the course. Should this happen, you will (a) need to drop the course or (b) receive a failing grade. In a course like this one, six absences is the equivalent of missing three weeks of class.

- An excused absence is one in which you miss class either for a required activity or because of illness (excessive excused absences can also result in you not passing the class).
- An unexcused absence is any other absence.

Arriving on time: This course begins at 2 pm every Monday and Wednesday. If you arrive after attendance has been recorded, then you will be counted late for that class session.

Accumulated lates: Three lates equals one absence. These add up more quickly than you'd think.

Classroom distractions: If you're doing something in class that has nothing to do with what we're covering that day, then I'm likely to be distracted by what you're doing. If you distract me, I will ask you as politely as possible to stop. If you persist in the distracting behavior, then you will be removed from class for the remainder of that day's class.

Use of Generative AI: Your instructor assumes that all work submitted by COMM 4393 students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

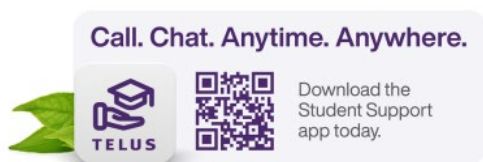

## Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
