Catalog Course Description:

CSCI 5391: This course will provide a broad range of current research topics in computer science and related fields to non-thesis track students to complete a major project and presentation to demonstrate the knowledge and skills. Non-thesis track graduate students in the MSCS program must register this course at the last semester of their graduate studies. This course is specifically designed for non-thesis track graduate students in the MSCS program.

Prerequisite(s): CCS department program graduate coordinator approval.

CSEC 5300: This course is focused on developing a student's research skills. Students will be guided through research of peer-reviewed journal articles and research methodologies as they relate to the field of cyber security. The instructor will guide students through a written review of research methodologies and current practices.

Objectives: The objective of the course is to analyze current research literature in computer science and cybersecurity by reviewing peer-reviewed journal articles and conference papers, to identify key problems, methods, and findings, then to design and develop research-based projects in selected topics with literature review, methodology, data collection, experiments, and analysis, and to present results and outcomes effectively.

Grading Policy: The final course grade will be based on your performance on the quizzes, exams, assignments and class participation using the following weights:

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
