**Catalog Course Description:** This course covers advanced topics in Operating systems. Course will cover subjects from the different OS environments: Windows, Linux, MacOS, mobile and web operating systems. Course will also focus on the assessment and evaluation of operating systems security. Course will be conducted on a research-based and students will work on current research trends in operating systems.

**Course Objectives:** This course covers advanced topics in operating systems. Key topics include the kernel, process and memory managers, file access, I/O driver, scheduler, etc. Throughout the course, a research approach will be adopted, and much time will be given to group discussion simulating an industrial environment. Students are collectively expected to analyze and document an operating system using MacOS, UNIX/Linux or Windows.

**Prerequisites:** Department Approval.

#### Student Learning Outcomes:

By the end of this course, students are expected to be proficient in details of operating systems and be sensitive to implementation and performance tuning of operating systems.

- Special focus will be on how to evaluate operating systems for security issues and how to handle such issues.
- Students will gain skills related to interaction with different operating systems from Apple, Linux and Windows environments.
- Students will learn about new OS mobile and web environments.

#### Required Materials:

- **Textbook:** Operating System Concepts, Tenth Edition, by Avi Silberschatz, Peter Baer Galvin, Greg Gagne, John Wiley & Sons, Inc., ISBN 978-1-119-80037-8.
- **Blackboard:** Connect to <http://tamusa.blackboard.com>. You will have lecture notes and other supplementary materials in Blackboard. All class communications will be through Blackboard and students should monitor this several times a day.
- **Software:** You will be required to use linux operating system.

- **Computer Hardware:** In order to participate in the tutoring sessions, you will need a computer with an internet connection, a microphone and speakers/headphones.
- **Time Expectation for coursework:** You are expected to spend 4-8 hours per week for the course. Based on the background, some student may require more time. Time spent may be longer when assignment/exams are due.

***Course Requirements every student must fulfill in order to succeed in course:***

The final letter grades will be assigned as follows: Above 90% → A; 80 – 89% → B; 70 – 79% → C; 60 – 69% → D; Below 60% → F.

**Examinations:** There will be a mandatory mid-term exam and a mandatory final exam (as per university schedule). Being absent / non-submission of an exam will result in a grade of zero for that exam and may result in a fail grade in the course. The exams will consist of conceptual multiple-choice questions, problem solving questions, and short essay questions. The exam materials will come from lecture notes, the text, and class discussions. Questions will emphasize understanding and applications of concepts and topics covered in class.

**Assignments:** There will be several assignments during the course. All assignments will have a clearly indicated due date.

**Make Up and Late Assignment/Exam policy:**

All assignments will have a clearly indicated due date. Late assignments will be penalized 10% per day. As a general rule, no make-ups will be accepted for any missed assignments/exams. Make-up may be

accepted/administered only in extraordinary circumstances such as an excused official university activity, a severe illness, or a dire emergency. However, you must provide comprehensive documentation either before or within a few days of the missed assignments/exams.

**AI Policy: Broader Use of Generative AI Permitted Within Guidelines**

Use of artificial intelligence (AI) tools, including ChatGPT, is permitted in this course for students who wish to use them. To adhere to our scholarly values, students must cite any AI-generated material that informed their work (this includes in-text citations and/or use of quotations, and in your reference list). Using an AI tool to generate content without proper attribution qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

**Class conduct and activity code:** Everyone in class is expected to follow all rules in the student handbook, as well as common courtesy during classroom lectures and discussions in class and online, including the following:

1. Attendance may be taken by an appropriate method by the instructor.
2. It is the students' responsibility to obtain and be able to use the required materials and software for this class.
3. Student must retain copies of all assignments and graded work for verification purposes and provide it to the instructor, if necessary. Keep own copies of all computer files and e-mails till final grade is received.
4. Talking while the instructor is lecturing is extremely disruptive and discourteous to the instructor and other students.
5. Using computers or phones (except for a valid urgent need) during class for a purpose not related to class is disruptive. All cell phones and gadgets should be turned OFF.
6. For any questions about the exams and assignments, a student should contact the instructor, well in advance of the day they are due, so the instructor may have enough time to provide feedback.
7. All communications will be via e-mail communications to the Texas A&M University e-mail account, and students are expected to use their school provided email account. The instructor will reply to a student e-mail messages and voice messages within 2 business days (Monday-Friday).
8. All assignment submissions must be uploaded as instructed by the due date and time. Submission window may close or marked late, even if late by one second.

Anyone violating these policies may be subject to disciplinary actions.

**Class attendance and Participation:** A vital part of every student's education is regular attendance of class meetings. Any absences tend to lower the quality of a student's work, and frequent or persistent absences may result in a failing grade. Students are responsible for the materials covered in class. The course covers a lot of material, and most students find at least some parts of it difficult. Class participation is highly encouraged as it makes the class more interesting and enhances the learning experience. Students are strongly encouraged to ask questions and participate in class discussions and problem solving. Good attendance and participation will be rewarded when final grades are assigned.

The course is intensive and challenging and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV
