Catalog Description and Prerequisites:

Course Description: This course is the study of how different biochemical, metabolic, and molecular pathways of the cell work together to produce the many functions of cells such as movement, response to hormones, growth, protein synthesis, etc. Topics of signal transduction pathways, protein targeting, secretion and endocytosis, and cellular organization and motility are covered. Cell-cell interactions and tissue formation will be discussed, including the loss of cell division control leading to cancer. With laboratory section. Prerequisites: BIOL 2411, BIOL 2431, CHEM 2323

Learning Outcomes:

1. Students will be able to describe the function of cellular organelles and cell membranes.
2. The students will also be able interpret cell theory and the endosymbiotic theory.
3. The students will be able to discuss cell basic functions of the cell including cell to cell signaling, motility, protein synthesis, and biochemical processes.
4. Students will be able to describe different cell death pathways and basic responses to pathogens and infectious agents.
5. Students will be able to describe key elements of the cell cycle control, mitosis, and meiosis.
6. Students will understand how cellular processes can be altered and lead to complex diseases such as cancer.

Course Content

LECTURE

5 Regular Exams – (100 points each; **each one is worth 10% of your overall final grade**; 5 tests = **50% of your overall grade**)

1 Final Exam – (The final is worth **15% of your final grade**). The final will be comprehensive.

- If you feel that your exam was graded incorrectly, I would be happy to discuss it with you.

Quizzes/Activities/Assignments – (Points will vary) - Activities may include computer-based activities, worksheets, small papers, quizzes, pre- and post-unit activities, etc. These will account for the remaining **10% of your grade**.

The remaining **25% of your grade will come from the lab** portion of the course.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
