Catalog Course Description: Principles, problems and structure of the United States monetary system. Operations of commercial banks, the regulation and control of the supply of money and credit and the organization of the Federal Reserve System.

Course Objectives: The objective of the course is to understand the overall financial system and how it is related to Federal Reserve's monetary policy. The focus of the course is on Financial Markets, Financial Institutions, and Central Banking

Prerequisites: None

Student Learning Outcomes:

After successful completion of the course, the student will be able to learn following things: 1) how financial market runs; 2) the role of money in the economy; 3) the economic interpretation of interest rate and how it affects the financial market; 4) an overview of recent financial crisis and its impact on the economy; 5) regulatory framework for financial institutions; and 6) the tools and conduct of monetary policy by the Federal Reserve. The learner outcomes will be assessed by responses to various quiz/exam questions.

Course Requirements:

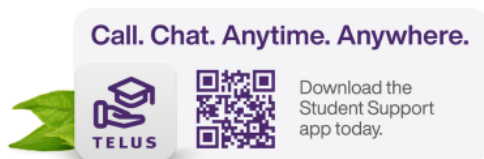

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
