Catalog Description:

Introduction to research in kinesiology. Prerequisite: program majors must have 12 advanced hours of kinesiology or EDKN 5338. EDKN 5338 may be co-requisite.

Course Learning Objectives:

This course is designed to prepare students to (a) read, understand, and evaluate research in the field of kinesiology and (b) construct a written research proposal. This course explores the concepts and procedures necessary for designing, conducting, and analyzing research in Kinesiology. The course will focus on the steps involved in the synthesis of a research project, including literature review, design, data collection and analysis.

Student Learner Outcomes (SLO): Upon completion of this course, each student will be able to:

1. Understand the difference between quantitative and qualitative research, the methods used to obtain these types of data, and appropriate study designs for these types of research.
2. Understand the need and importance of research in the field of kinesiology.
3. Critically analyze research in an area of interest.
4. Demonstrate knowledge of ethics in research.
5. Search and acquire research articles relevant to a topic of interest.
6. Have an applied understanding of basic statistical techniques.
7. Know the steps needed to acquire approval from an IRB board for research using human

participants.

8. Design a research project worthy of graduate research project or thesis material.

Evaluation of Student Outcomes and Course Requirements: Evaluation is based upon the attainment of the course outcomes as evidenced by the successful completion of all course requirements. Those course outcomes cannot be successfully attained without thorough preparation and active, thoughtful participation.

Merely submitting an assignment in itself does not warrant an “A.” Earning an “A” requires greater attention to the quality of the work. It behooves you to have a colleague proofread your work before submitting it. Your ability to communicate in writing is as important as understanding the content.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

The Six-Drop Rule

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
