Course Learning Objectives: This course's goal is to inform and influence the leadership practices of students and to contribute to the student's scholarly growth. Theories are discussed chronologically, as they emerged and were influential during the past 200 years, with a principle focus on modern theories. However, current conversations on leadership frame the initial and final discussions in the course and provide a context for considering the historical divisions of theory. Students in this course will be expected to articulate their leadership and managerial philosophies on various topics and to articulate effective leadership skills. Students will also formulate research questions for possible further exploration.

Student Learner Outcomes (SLO): As a result of the class and successful completion of course assignments and lessons, students will:

1. Students will be able to demonstrate orally and in writing a knowledge base fundamental to philosophy.
2. Students will be able to explain the philosophical positions and name the key advocates of the following: Idealism, Realism, Thomism, Perennialism, Essentialism, Pragmatism, Progressivism, Existentialism, and Postmodernism.
3. Students will plan, prepare, and participate in online presentations about the theory of philosophy.
4. Demonstrate the ability in analyzing philosophical conflicts and contemporary issues.
5. Students will be able to articulate a compelling and distinctive personal philosophy.
6. Demonstrate problem solving ability and decision making skill in considering theoretical philosophy..

Performance Evidence: This course will be administered through readings, practical exercises, online resources, and discussion/reflection. The critical assignment is designed to demonstrate the student's

competency of learner outcomes. On-line activities will provide opportunities for application.

Instructional Strategies and Methods: This F2F class course contains multiple assignments and a quality style leadership term paper.

Course Objectives: This is a challenging course. You should expect to work hard. Use this class as an opportunity to learn about leading and what you should expect in a professional working environment. I want you to share your information, insights, and experience. Approach this class as you would a job – submit work on time and be prepared to do your best.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV

regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

The Six-Drop Rule

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
