#### **Course Description**

This course provides a solid background in ecology and introduces the student to the scientific study of organisms and their environment. We will address the basic abiotic and biotic components involved in the function and evolution of ecosystems, different ecological models, and the mechanisms that drive ecosystem changes through time. The course will incorporate the classic concepts of ecology and will introduce the students into current theoretical and applied aspects of ecology, from a global scale to the organismal level.

#### **Course Objectives**

1. Develop an appreciation of past and modern scope of scientific inquiry in the field of Ecology, through Laboratory exercises.
2. Learn how to formulate ecological questions, followed by a hypothesis, objectives, and methods of inquiry to test the proposed hypotheses.
3. Understand how scientific studies in ecology are conducted including techniques, methods and the equipment used to address different ecological questions.
4. Become familiar with data collecting protocols, sample analysis in the laboratory, and statistical data analysis using Microsoft Excel among other software.
5. Learn how to record field observation and experimental results in a laboratory notebook
6. Learn how to organize and present results in your laboratory notebook using tables and figures
7. Learn how to describe and interpret the results presented in tables and figures

### **Course policies**

**Make up Labs:** No Make-up Labs are granted. If absent during the online or face to face session you are expected to communicate in written form in advance or no later than 24hrs from your absence. If a valid excuse is provided, and accepted by instructor, you may submit a lab report but will not get points for attendance or full credit. If you have more than 3 absences, you may not get lab credit.



**Late assignments:** for each day passed the due date, 10% will be deducted over the total possible points.

**Lab Report:** Lab reports will be submitted online and due date will be indicated by instructor. Lab report instructions will also be submitted via blackboard by instructor. Lab report cannot be submitted and will not be accepted if sent to my e-mail.

**Field Lab Report:** You will submit a lab report in a field notebook for each field lab (2) conducted this semester, submitted in person.

### **Course Evaluation**

- **You will be asked to complete and sign a series of forms during our first day of Lab. These forms are mandatory for all field trips and failure to submit them means that you cannot participate in field trips.**

**Field Lab Report:** You will submit a lab report in a field notebook for each field lab (2) conducted this semester, submitted in person.

Students will document their observation, data, and analyses from lab and field activities in their lab notebooks. This assignment involves maintaining accurate and organized records.

Formal lab reports are turned in digitally and the lab will indicate whether a formal lab report is required. 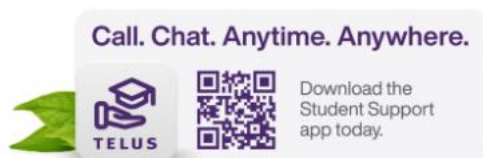

**Financial Aid and Verification of Attendance:** According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
