**Catalog Course Description:** Foreign exchange markets, balance of international payments, short-term borrowing and investment decisions. Changes in exchange rates: pricing, profitability and output decision, international aspects of capital decisions. TSI Restriction(s): Reading, Math, and Writing.

**Course Objectives:** This course is an introduction to the fundamentals of international financial management. In this course, students will be introduced to the financial problems that corporations face as a result from operating in an international environment. Major topics covered include, but are not limited to, corporate strategy and the decision to invest abroad, forecasting exchange rates, managing exchange risk, multinational capital budgeting and cost of capital, and sources of financing.

**Textbook:** International Finance Management 10th ed, Eun, Resnick, and Chuluun. McGraw-Hill 2024. Available online on Blackboard.

**Prerequisites:** Grade of C or better in FINC 3310, FINC 3337 or equivalent. Graduate level students may not enroll.

**Student Learning Outcomes:** after successful completion of this course, students will be able to:

- Explain the international monetary and financial system
- Describe the international parity conditions

- Describe the foreign exchange market and analyze the foreign exchange rate determination
- Explain management of foreign exchange exposure
- Analyze the financing of a global firm
- Analyze foreign investment decisions.

**AACSB Assessment:** The College of Business has obtained AACSB accreditation. Students may be assessed on program level outcomes based on course outcomes from various courses. The materials from this course may be used for assessing such program level outcomes, and hence students must follow the necessary rigor to ensure mastery and retention of the above course outcomes.

**Blackboard:** visit <http://tamusa.blackboard.com> to access lecture notes, eBook, exams, assignments, solutions to selected problems. All class communications will be through Blackboard (via Announcements).

**Optional readings:** You should also keep current with business news in publications such as The Wall Street Journal, Bloomberg Business Week, The Economist and other business journals. Bloomberg TV, MSNBC, Fox Business Channel and Nightly Business Report on NPR also provide interesting insight into investment and current business topics. Additional reading materials are available on the course website as recommended by the instructor.

**Time expectation for coursework:** You are expected to spend 4-8 hours per week for the course. Based on the background, some students may require more time. Time spent may be longer when assignment/exams are due.

### **Course Requirements every student must fulfill in order to succeed in course:**

1. Students should check the Course Calendar, Announcements, and Messages (e-mail) systems in Blackboard on a regular basis.
2. Students should keep current with all course assignments, quizzes, and examinations.
3. Students should ask questions and communicate with the instructor either in class, online, off-line or during office hours.
4. For all classwork, exams, quizzes etc., if a student is completing it off-campus, then they are responsible for availability of internet connectivity. Extensions will **not** be granted for lack of availability of internet connections.
5. Students should remember that online courses assume greater responsibility and independent learning skills by the student for their own learning outcomes.
6. This class is online. All materials will be made available through Blackboard or through online links.

**Grading Policy:** The final course grade will be determined from your performance as follows:

- Blackboard assignments: **45%**
- Class participation: **5%**

Final letter grades will be assigned as follows: **A** ( $\geq 90\%$ ), **B** (80% to 89%), **C** (70% to 79%), **D** (60% to 69%), **F** ( $\leq 59\%$ )

**Examinations and Quizzes:** There will be a mandatory mid-term and a mandatory final exam (as per university schedule). Being absent / non-submission of an exam will result in a grade of zero for that exam and may result in a fail grade in the course. The exams/quizzes will consist of conceptual multiple-choice questions, problem solving questions, and short essay questions. The exam/quiz materials will come from lecture notes, the textbook, and class discussions. Questions will emphasize understanding and applications of concepts and topics covered in class. Examinations will be during the class time.

**Assignments:** There will be several weekly homework assignments through Blackboard during the course. Individual assignment statements and due dates will be posted through Blackboard.

**Make up and Late Assignment/exam/quiz policy:** As a general rule, make-ups or late submission0s will NOT be offered or accepted for any missed assignments/exams/quizzes. Late submissions or make-ups may be accepted/administered only in extra-ordinary circumstances such as an excused official university activity, a severe illness, or a dire emergency. However, you must provide comprehensive documentation either before or within a few days of the missed assignment/quiz/exam.

**Class conduct and civility code:** Everyone in class is expected to follow all rules in the student handbook, as well as common courtesy during classroom lectures and discussions in class and online (if the university decides to temporarily move to an online delivery method), including the following:

1. Attendance may be taken by an appropriate method by the instructor.
2. It is the students' responsibility to obtain and be able to use the required materials and software for this class.
3. Student must retain copies of all assignments and graded work for verification purposes and provide it to the instructor, if necessary. Keep own copies of all computer files and e-mails till final grade is received.
4. Talking while the instructor is lecturing is extremely disruptive and discourteous to the instructor and other students.
5. Using computers or phones (except for a valid urgent need) during class for a purpose not related to class is disruptive. All cell phones should be muted or turned OFF.
6. For any questions about the exams and assignments, a student should contact the instructor, well in advance of the day they are due, so the instructor may have enough time to provide feedback.
7. All communications will be via e-mail communications to the Texas A&M University e-mail account, and students are expected to use their school provided email account. The instructor will reply to a student e-mail messages and voice messages within 2 business days (Monday-Friday).
8. All assignment submissions must be uploaded as instructed by the due date and time. Submission window may close or marked late, even if late by one second.

Anyone violating these policies may be subject to disciplinary actions.

**Class attendance and Participation:** A vital part of every student's education is regular attendance of class meetings. Any absences tend to lower the quality of a student's work, and frequent or persistent absences may result in a failing grade. Students are responsible for the materials covered in class. The course covers a lot of material and most students find at least some parts of it difficult. Class participation is highly encouraged as it makes the class more interesting and enhances the learning experience. Students are strongly encouraged to ask questions, participate in class discussions and problem solving, and visit/contact the instructor during office hours in case of questions or concerns. Good attendance and participation will be rewarded when final grades are assigned.

The course is intensive and challenging and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important, and may vary considerably based on student background. However, a **minimum** of two hours of work outside the class is expected for every one hour of class period per week. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
