### Course Overview

Origin and development of the U.S. Constitution, structure and powers of the national government including the legislative, executive, and judicial branches, federalism, political participation, the national election process, public policy, civil liberties and civil rights.

## Course Requirements

**Exams** - There are two exams in this course, a midterm and a final exam. The exams will take place in class and are scheduled in the syllabus (see below). Each exam will consist of a combination of multiple choice, true/false, and short answer questions. The midterm exam will be worth 125 points and the final exam will be worth 175 points. A study guide will be provided prior to each exam, and we will also have an in-class review session prior to each exam. (300 total points)

**Quizzes** - There are 11 weekly quizzes in this course. Each quiz will cover the chapter for that week and any additional reading assigned. Each quiz is worth 12 points with 1 point per question. I will drop the lowest quiz score and make up quizzes will only be given in the case of excused class absences (120 total points)

**Writing Assignments** – There are two writing assignments in this course. The due dates for the assignments are below, and each assignment will require students to use a readily available data source or a primary written source to answer specific questions about American politics. Each assignment is worth 50 points and will be 3-5 pages in length (100 total points).

**Participation/In class Assignments** – The participation grade for class is based on two components – class participation and completion of in class assignments. For the most part if I can tell the student put in a good faith effort on the assignments and their participation, they will receive full credit but if not, they will be docked points. The assignments are designed to be completed in class so that means students must be present in class to participate. Make up in-class assignments will be given only when the students are gone from class for an excused absence (i.e., illness or university sponsored event) (100 total points)

## Attendance Policy

Students are expected to attend every class. If a student is unable to attend class, they should notify the professor as soon as possible. To be eligible for a make-up quiz or exam, or for turning in a late assignment a student must have an excused absence from class. Excused absences are those where a student cannot attend class because of an illness, family emergency, or because they are attending a school sponsored event on or off campus.

I will accept late writing assignments for one week passed the deadline, but those late assignments must be for excused absences only. I will also allow make up quizzes but again only for excused absences only. If a student is unable to take an exam on the scheduled date, they must notify the instructor as soon as possible. Make up exams will only be given for excused absences (i.e. illness, family emergency, school sponsored event)



### Financial Aid and Verification of Attendance:

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a

does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

4. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

#### Students' Responsibilities

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, [Student Code of Conduct](#), on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
