**Course Description:**

This course is an introduction to the institutions and political processes of the federal government. Topics to be covered include constitutionalism, political culture, civil rights and civil liberties, bureaucracy, political parties, interest groups, and the role of the media, among others. We will survey the general institutions and cultural underpinnings of the federal government as structures that shape public policy and political experience.

Throughout the semester, we will attempt to answer several core questions concerning government: What are the critical institutions of federal government and how do they shape our political life? What is the nature of political culture and how does it affect our politics? Ultimately, the goal of this course is to help each member of the class arrive at a deeper, more comprehensive understanding of the forces that shape government and politics, so that he or she may be both a more discerning student and critic of the system and a more informed and reflective participant in it.

**Student Learning Objectives**

After completing GOVT 2305 students will be able to do the following:

1. Explain the origin and development of constitutional democracy in the United States.
2. Demonstrate knowledge of the federal system.
3. Describe separation of powers and checks and balances in both theory and practice.
4. Demonstrate knowledge of the legislative, executive, and judicial branches of the federal government.

5. Evaluate the role of public opinion, interest groups, and political parties in the political system.
6. Analyze the election process.
7. Describe the rights and responsibilities of citizens.
8. Analyze issues and policies in U.S. politics.
9. Express oneself with precision and clarity, whether orally or in writing.

### **Grading**

This is a face-to-face course. This means that this class will be conducted exclusively in person. Attendance for both Monday's and Wednesday's class is highly encouraged, and mandatory, and will consist of lecture and discussion. Exams and writing assignments will be accomplished outside the classroom.

Your grade for this course will be based on the following: Chapter Questions (10%), Class Participation (20%), Writing Assignments (20%), Module Exams(25%) and a Final Exam (25%). Submissions with vague and generic language that omit the specific issues/questions raised in the assignment prompt and class lectures will get a maximum grade of 10%.

All assignments outside of class will be given with several days to be completed, so, it is the students' responsibility to ensure a working internet connection. The only exception will be in the event of technical problems that affect the entire class (i.e. BlackBoard becomes unavailable). However, if the student is aware of a personal issue that prohibits him/her from complying with the stated deadline, this must be discussed with the professor before the end of class on the day the assignment is issued.

Students must be present for all module exams and the final exam, since any unexcused absence (see attendance policy, below) will result in an automatic zero (0). If a student has an excused absence on the day of a module exam, the next class date will be used to complete the exam, during the professor's office hours. The only opportunity students will have to take the final exam will be during class hours on Wednesday, May 13, 2026. There will be no exceptions to this rule.

### **Late Work**

Any assignment completed after the assigned deadline will NOT be accepted, regardless of circumstances, resulting in a grade of "zero".

There will be no “extra credit” assignments given in the course of this class.

### **Course Requirements**

• **Attendance:** “Students are expected to attend all scheduled activities for all of the classes for which they are registered” ([A&M-SA attendance policy](#)). This class will be held with a 12..5% unexcused policy before dropping students. The only excused absences that will be accepted fall under the following categories:

• **Readings:** Readings for each class period should be completed before beginning the class. You are responsible for all required reading materials.

• **Discussion Assignments:** Class participation will take place in class throughout the semester. Students must be familiar with the subject matter prior to the start of class and are expected to engage in the topic being discussed.

• **Writing Assignments:** Posted on BlackBoard and due no later than 10:00 pm on the posted deadline. Writing assignments can be double/single single-spaced, 12-point Times New Roman, and at least 500 words in length to be considered for minimum credit. All essays must be typed or copied/pasted into the Blackboard text box; a hyperlink link (ie Google Docs) to the essay will not be accepted and will result in a “zero” grade.

• **Module Exams:** A total of 5 module exams will be given, and students will have one attempt with time restrictions. These exams will consist of multiple-choice questions. The test will be taken in the classroom, and the lowest grade will be dropped.

• **Final Assignment:** The final assignment will consist of multiple-choice questions, which wil be taken in the classroom at the end of the semester.
