Course Description: This course provides a comprehensive overview of cognitive, physical, and psychological development aspects across the lifespan. Various theories associated with the developmental process will be explored and discussed. Special emphasis will be devoted to linking theory with practice across multiple settings (school, agencies, home).

1. Students will learn the influence that biological factors have on the development of a fetus.
2. Students will learn the influence that diseases, nutrition, and physical injuries have on the development of an individual over his/her lifetime.
3. Students will learn to the influence of the environment on the individual as he/she develops over their lifetime to include the role of education and social interaction.
4. Students will learn to understand the effect that not only society in general has on the development of an individual over his/her lifetime, but they will also understand the unique effect each individual's culture also has on his/her development.
5. Students will be able to develop treatment programs for individuals taking into consideration the role that human development has on the approaches used.
6. Students will learn the different theoretical approaches to understanding human development including psychodynamic, behavioral, and cognitive approaches.
7. Students will learn the effect of human development on an individual's ability to work and will learn how work influences human development.

Human Development Paper

In this paper, the student will:

1. Apply theories of human development to a mock client situation
2. Discuss potential treatment approaches and interventions for the mock client based on counseling and human development theories
3. Discuss any limitations and factors that may impact counseling treatment

This paper will be at least four full pages of text (not including cover page and reference page). Students will choose a topic from instructor's list of acceptable counseling situations. Three professional journal reference articles will be the minimum. The paper must be in APA style.

Student papers will include the following:

1. Cover page
2. Reference page – APA style
3. Three professional counseling journal articles related to the topic. These three articles are to be turned in with the paper.

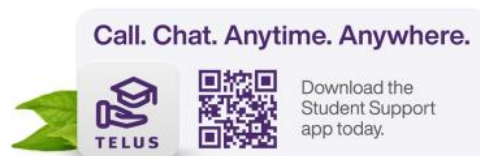

Use of Generative AI Permitted Under Some Circumstances or With Explicit Permission: There are situations and contexts within this course where you may receive permission to use artificial intelligence (AI) tools. The instances approved for use of tools such as Chat GPT, Claude, and Grammarly in this course include (a) collaborative interfacing that supports your understanding concepts more clearly, and (b) copyediting for clarity, grammar, and punctuation improvement. These

and other AI tools are not approved for any generation of content ranging from (a) substantive edits including sentence and paragraph enhancement, or (b) general content generation (text, video, audio, images) that will be submitted to represent any student work (assignments, activities, discussion responses, etc.) that is part of your evaluation in this course. These latter instances constitute authorship which is problematic for two principal reasons: (a) authorship requires the assumption of responsibility for content and the consent for content usage which AI software cannot provide, and (b) over-reliance on these tools may hinder the graduate students' development of essential skills related to authentic expression and representation of ideas, the creative process, critical thinking, conceptualization and organization of complex issues, and written expression which are fundamental to the professional identity development. Thus, all written assignments in this course will require an AI disclosure statement on the students' title page that identifies the full name of the tool used with version number, how it was used, and the reason for use. This statement will be considered against data such as the Turnitin similarity and AI writing detection values to ensure that students are accurately receiving credit for their written assignments. One guideline for this course is instances in which more than 10% of the student work may have been generated by generative AI will prompt deeper inspection by the instructor. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M University-San Antonio's standards of academic integrity.

Class Attendance: A vital part of every student's education is regular attendance of class meetings. Any absences tend to lower the quality of a student's work in a course, and frequent or persistent absences may preclude a passing grade or cause a student to be dropped from one or more courses upon the request of a faculty member to the Provost and Vice President for Academic Affairs. Excessive absences (more than 2) will result in a grade letter deduction from your final grade for each absence. Please email before class if you will be out. Two tardies (entering 10 minutes or later after class begins or leaving 10 minutes or earlier before class ends) will count as one absence.

Incompletes: The spirit of the "Incomplete" is to give a student an opportunity to complete a course after the end of the semester. An Incomplete will only be considered under specific circumstances: 1. 70% of the class has been completed and student is passing with a "C" or better 2. The circumstance for which the "I" is requested is supported with documentation 3. Student has been attending class on a regular basis Incompletes are not to be used to remedy excessive absences. Unforeseen circumstances precipitating the request for an "I", should occur near the end of the semester. Students who are experiencing difficulties at the beginning or midway through the course should contact their professor immediately to discuss options. When a professor agrees to grant an "I", a contract between the student and professor that outlines a specific timeline for completion of the course will be generated. Topics such as highest possible grade will also be outlined. If the contract is not fulfilled, the professor will submit a change of grade form with earned letter grade. All "I"s will automatically revert to an "F" after one year.

Dropping a Course: Each student is responsible for knowing the drop date for any given semester. Professors are not responsible, under any circumstances, for "dropping" a student from a course. Please be aware that if you do not formally drop a course and fail to fulfill the academic requirements, the professor will submit the earned grade.

Tests

Students are responsible for all information in text, PowerPoints, lectures, and class discussions. Since class is hybrid, students are to read/review content outside of class. Tests will be multiple choice and short answer.

Modules

Students are responsible for completing reading materials and modules outside of class time. You will be asked to complete a module prior to class that asks a question related to the assigned material that will count towards your participation grade.

Human Growth and Development Paper

In this assignment, you will apply a specific human development theory to a provided (or self-created) mock counseling scenario. Your goal is to demonstrate how developmental knowledge informs assessment, case conceptualization, and treatment planning.

Part 1: Case Selection & Client Profile

Identify a "mock client" (either from the provided course case studies or one you have developed). Provide a brief demographic summary:

- **Age and Life Stage:** (e.g., Middle Adulthood, 45 years old).
- **Presenting Concern:** A brief description of why the client is seeking counseling.
