

International Human Rights

This course provides students with a basic understanding of the normative foundations of human rights, the international law of human rights, and the politics of creating and enforcing human rights standards both domestically and internationally

Student Learning Objectives

Upon completion of this course students will be able to:

- Describe the history of the emergence of human rights norms after the Second World War
- Understand the gap between international human rights law and the national implementation of human rights
- Trace how human rights goals are achieved through international institutions and the efforts of non-governmental organizations
- Assess different challenges to the implementation of human rights including globalization, development, and terrorism
- Write a literature review using the scholarly literature on international human rights

Grading Scheme

Participation and Attendance – 15%

This grade will be based on student's attendance in class as well as their willingness to participate in each class/discussion. This is a small class that is largely based on discussion of the readings (rather than lecture) so attendance is very important. More than two absences will count against the student's grade.

Exams – 20%

There will be two exams that will each count for 10% of the student's grade.

Reading – 10%

Readings for each class will be posted in Perusall. They will be due before class starts. Perusall will evaluate quality of student's reading and comments and give a grade. Ordinarily a 1 will score between a 0 and a 70 depending on the amount of time spent on the reading, a 2=85 and 3=100. These grades will be averaged together to form the reading grade. I will drop one reading grade so students can miss one chapter.

Assignments – 40%

There will be 10 short individual assignments designed to help students construct their literature review. Each assignment will be worth 4%. Assignments 2-10 will be informally presented to the class, so in order for students to receive full credit, they must be present in class the day the assignment is due.

Literature Review – 10%

At the end of the semester, students will combine the individual assignments into a literature review on a topic of their choosing. Students will be allowed to choose their own topics for the literature review, and should submit their topics to me no later than Jan 21. However, I do not want two students covering the same topic so if two students choose the same topic the student that submitted their choice first will be allowed to cover that topic. Please note that we have a new university policy put in place this semester. Policy 08.01 states that, "Advocating race or gender ideology, sexual orientation, or gender identity is prohibited, unless the course and the relevant course materials are approved in advance by the university president." Regarding student led projects faculty have been informed that "The faculty member must remain neutral and avoid nudging the student or encouraging the student to pursue such topics in a course that is not approved for such a focus." Please keep this regulation in mind when choosing a topic for the literature review as this course has not been pre-approved to cover topics outlined in policy 08.01.

Class Policies

Late Work Policy

I will not accept late reading assignments, because readings are designed to be discussed in class, instead I will drop one reading assignment. For the 10 individual assignments, students will receive 10% off of the grade for each day it is late. If students are not prepared to present their individual assignments the date they are due, they may be asked to present them in a later class (class time permitting).

AI Policy

This course assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity. The prohibition on the use of AI extends to answering questions in Perusall. Students suspected of using AI will be asked to give an oral defense of their work.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the

U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Please note that any student who stops attending at any time during the semester, a Care report will be submitted, and you will possibly be dropped from the class. The Six-Drop Rule

Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive

drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
