**MAJOR COURSE DESCRIPTION AND REQUIREMENTS**

**Catalog Description 2302 Principles of Managerial Accounting** is an introduction to the fundamental concepts of managerial accounting appropriate for all organizations. Students will study information from the entity's accounting system relevant to decisions made by internal managers, as distinguished from information relevant to users who are external to the company.

**Course Objectives**

After successful completion of this course, students will be able to describe and perform:

1. Financial ratios and gross margin/gross profit percentages
2. Managerial cost concepts such as fixed, variable and overhead costs
3. Break-even analysis (Cost-volume-profit)
4. Capital acquisition analysis (Net Present Value)
5. Accounting requirements for cost accumulation and application;
6. Cost standards and procedures;
7. Budgeting and forecasting;
8. Basic considerations in quantitative analysis for managerial decision making.

**EXAMINATIONS**

There will be one (1) midterm exam during the semester and a **comprehensive** final exam as well as online quizzes using McGraw/Hill Connect. The quizzes will consist of representative problems from each chapter as well as conceptual multiple-choice quizzes covering information in the lecture notes, the text, and class discussions. The mid-term exam is problem-based and covers the first half of the course. The final exam is also problem based and is comprehensive.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
