**Course Description:** This is a recitation course in support of Introductory Statistics 003. Students will study the collection, analysis, presentation and interpretation of data, and probability. Analysis includes descriptive statistics, correlation and regression, confidence intervals and hypothesis testing. Appropriate technology used. This course meets the standards for the Mathematics category of courses under the core curriculum. Prerequisite: Evidence of math equivalent to High School Algebra II ("C" or higher) or placement.

#### Financial Aid and Verification of Attendance
