Catalog Course Description

This course introduces the fundamental concepts of financial accounting in accordance with U.S. Generally Accepted Accounting Principles (GAAP). Students examine procedures used to identify, measure, record, and communicate financial information affecting business organizations.

Course Objectives

Students will:

1. Gain an understanding of financial accounting terminology and concepts.
2. Apply accounting concepts to analyze business transactions.
3. Develop problem-solving and decision-making skills using financial information.
4. Learn to locate and use appropriate resources to answer accounting-related questions.

Student Learning Outcomes

Upon successful completion of this course, students will be able to:

1. Explain the difference between cash and accrual accounting.
 2. Apply the basic accounting equation.
 3. Prepare the four primary financial statements.
 4. Identify and explain key components of financial statements (assets, liabilities, revenues, and expenses).
 5. Explain the relationships among financial statements.
 6. Record and analyze transactions using journal entries, T-accounts, and debits and credits.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. The Six-Drop Rule

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
