Course Description

A survey of the functional areas of business. Major topics include: the economic, legal, social and global environment in which modern businesses operate; social responsibilities of business; forms of business ownership; functions and responsibilities of managers; and fundamental concepts of marketing, accounting, finance, information management, and labor relations and human resource management.

Student Learning Outcomes

After completing BUAD 1301, the student will be able to:

- Correctly define and use a variety of business-related terms.
- Conduct basic research on business topics using the Internet and other resources and clearly communicate the results of that research in written form.
- Describe the key elements of the business environment.
- Identify the major stakeholders in a business enterprise.
- Describe the advantages and disadvantages of the four major forms of business ownership.
- Discuss how securities markets meet the needs of both businesses and investors
- Explain the significance of accounting for the internal and external stakeholders of a company.
- Describe the way a firm can finance its operations.
- Describe the key elements involved in marketing a company's goods and services.
- Explain the role of operations management in producing and distributing a company's goods and services.
- Describe the basic functions performed by managers.

Required Materials

- Understanding Business: The Core, Third Edition, by Nickels/McHugh/McHugh ISBN: The Connect Code is required to complete assignments/quizzes & exams. It comes with an eBook and if you decide, you want a loose-leaf copy of the book you can get one for \$25 with the Connect Code.
- Blackboard: Connect to <http://tamusa.blackboard.com>. You will have SmartBook (readings+integrated quizzes), written assignments, PowerPoint slides, recorded Zoom chapter lectures, and other

supplementary materials in Connect. Check announcements, emails, and class communications through Blackboard and Connect daily.

- **Computer Hardware:** In order to participate in the tutoring sessions you will need a computer with an internet connection, a microphone and speakers/headphones.
- **Time Expectations for coursework:** You are expected to spend 4-8 hours per week for the course. Based on the background, some students may require more time. Time spent may be longer when assignment/exams are due.
- **Other Recommended / Reading Materials:** Additional reading materials are available on the course website as recommended by the instructor.

Course Requirements every student must fulfill in order to succeed in this course

- Students should check the Course Calendar, Announcements, and Messages (e-mail) systems in Blackboard on a regular basis.
- Students should keep current with all course assignments, quizzes, and examinations.
- Students should ask questions and communicate with the instructor either in class, online, off-line or during office hours.
- For all classwork, exams, quizzes etc., if a student is completing it off-campus, then they are responsible for availability of internet connectivity. Extensions will not be granted for lack of availability of internet connections.
- Students should remember that online and hybrid courses assume greater responsibility and independent learning skills by the student for their own learning outcomes.

Course Format and Instructional Methods:

This is a blended course, where significant portions of the course will take place both in a traditional face-to-face classroom and also online via Blackboard. Within the course Blackboard site you will access the learning materials and syllabus; submit assignments; take quizzes. Refer to the course calendar/schedule and assignment instructions for information on where and when to submit your work.

Classroom Protocol

Everyone in class is expected to follow all rules in the student handbook, as well as common courtesy during classroom lectures and discussions in class and online, including the following:

- It is the students' responsibility to obtain and be able to use the required materials and software for this class.
- Student must retain copies of all assignments and graded work for verification purposes. Keep copies of all computer files and e-mails.
- Talking while the instructor is lecturing is disruptive and discourteous.
- For any questions about the exams and assignments, a student should contact the instructor, before the day they are due, so the instructor may have enough time to provide feedback.
- All communications will be via e-mail communications to the Texas A&M University e-mail account, and students are expected to use their school provided email account and reference the course name and number. The instructor will reply to a student e-mail messages by the end of the next business day.
- All assignment submissions must be uploaded by the due date.

Course Requirements

The final course grade will be based on your performance on the quizzes, exams, assignments and class participation. Within each category, items will be equally weighted. Your course grade will be calculated by weighting each category as follows:

The final letter grades will be assigned as follows: Above 90% \Rightarrow A; 80 – 89% \Rightarrow B; 70 – 79% \Rightarrow C; 60 – 69% \Rightarrow D; Below 60% \Rightarrow F.

Makeup and late assignment/quiz/exam policy

As a general rule, make-ups or late submissions will not be offered or accepted for any missed assignments/exams/quizzes. Late submissions or make-ups may be accepted/administered only in extraordinary circumstances such as an excused official university activity, a severe illness, or a documented emergency. Where feasible, you must provide documentation either before or within two business days of the missed assignment/quiz/exam.

Course requirement details

Connect Orientation Assignments

There are three orientation assignments in McGraw Hill Connect. You access these through blackboard. These are due before the second class meeting—please see your blackboard calendar for specific due dates. These will be graded as a percentage correct and then the average of the 3 scores will account for 5% of your total course grade.

Smartbook Assignments

These are completed through McGraw Hill Connect (accessed through blackboard). Each week you have one smartbook assignment due. These will take you through the assigned chapter and will have interactive components to strengthen your learning. You are allowed to drop or miss one smartbook assignment. Your highest 13 smartbook assignments will be averaged and account for 25% of your grade.

Chapter Quizzes

You have a McGraw Hill Connect quiz (access through blackboard) for each chapter. These are open book, but you must complete them independently. You may take each quiz an unlimited number of times before the weekly deadline, only your highest score will count. You are allowed to drop or miss one quiz. Your highest 13 quizzes will be averaged and account for 20% of your grade.

Connect Chapter Assignments

You have a McGraw Hill Connect assignment for each chapter (access through blackboard). You may attempt each assignment an unlimited number of times before the deadline—only your highest score will count. You are allowed to drop or miss one Connect Chapter Assignment. Your highest 13 assignments will be averaged to account for 10% of your final course grade.

Manager Hotseat Cases

You have 11 Managers Hotseat Cases on McGraw Hill Connect (access through Blackboard). Please see your blackboard calendar for specific due dates. Again, you have an unlimited number of attempts before the due

date, only your highest score will count. You are allowed to drop or miss one Hotseat case. The remaining 10 will be averaged to account for 10% of your grade.

Reflection papers

You will have three reflection papers, each worth 5% of your final grade. These will be announced in class and through blackboard at least 2 weeks before the due date. You must complete these reflection papers independently. Papers will be submitted through blackboard, and will account for a total of 15% of your course grade. The College requirement listed below will fulfill part of these requirements and will be discussed in more detail in class.

The College of Business has scheduled a series of activities designed to enrich your undergraduate learning experience. A detailed schedule of the activities, including dates and times, will be provided.

Participation in one activity is a **mandatory** component of this course and contributes to 10% of your overall grade.

Failure to meet the participation requirement without documentation may result in a reduction of your grade for the course. Please contact your instructor immediately if you anticipate challenges with fulfilling this requirement so accommodations can be discussed.

Final Exam

We will have a closed notes final exam in this course. The exam will cover material from the entire semester. A study guide will be provided 2 weeks before the exam. This exam must be completed independently, and is worth 10% of your total course grade.

Participation/attendance

Attendance will be taken at every in-person class session. The instructor will provide name tents for each student to place at their desk during class. Students are responsible for getting their name tent from the instructor at the start of each session, and must return it to the instructor at the end of class. This process will be used to document attendance: if a student forgets to return their name tent they will not get credit for attending that session. You are allowed one unexcused absence during the semester. If you are ill, please email your instructor before class. Any additional absences will reduce your score. Attendance makes up 5% of your total course grade.

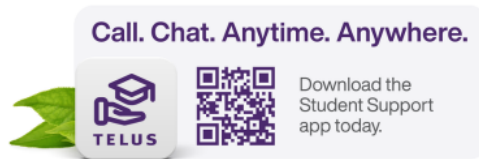

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
