Catalog Description: This course provides a structured laboratory component to supplement and reinforce calculus concepts presented in MATH 2313. Concurrent enrollment in MATH 2313 is required.

Prerequisite: MATH 2312 with a grade of "C" or higher, or equivalent, or consent of the department.

Corequisite: MATH 2313.

Textbook: This course uses the textbook adopted for MATH 2313. No additional textbooks are required.

Course Overview: This course runs concurrently with MATH 2313 (Calculus I) and provides applied laboratory experiences that reinforce concepts of limits, derivatives, and optimization

Student Learning Outcomes: Upon completion of the course, students will be able to:

- 1. Classify characteristics of functions correctly using the language and notation of limits.*
- 2. Analyze the nature of functions using differentiation.*
- 3. Optimize outcomes to real world problems.*

Assignments:

This course consists of a series of laboratory activities. The two lowest lab scores will be dropped. Attendance will be recorded at each lab session. Laboratory activities account for 90% of the final lab grade, and lab attendance accounts for the remaining 10%.

Students will typically work in groups of three and will submit one lab report per group. At the instructor's discretion, some lab sessions may be used for review of course topics.

Calculator Policy: Scientific non-graphing calculators are permitted. Graphing calculators or online math utilities (e.g., Desmos) are not allowed on exams.

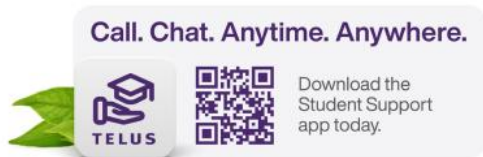

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Jaguar Writing, Language, and Digital Composing Center (WLDCC): The Jaguar Writing Center provides writing support to graduate and undergraduate students in all three colleges as well as faculty and staff. Writing tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. Our language tutors support students enrolled in Spanish courses and students composing in Spanish for any assignment. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
