**Course Overview:** In-depth combined study of algebra, trigonometry, and other topics for calculus readiness. This course meets the standards for the Mathematics category of courses under the core curriculum and address the following required objectives: Critical Thinking, Communication, and Empirical Quantitative Skills.

**Prerequisites:** MATH 1314 College Algebra with a grade of “C” or higher.

## Student Learner Objectives

- Students will analyze, represent, and interpret functions—including linear, polynomial, rational, exponential, logarithmic, and trigonometric functions—using symbolic, graphical, numerical, and verbal methods to model real-world situations.
- Students will perform algebraic operations on expressions and equations (factoring, solving equations and inequalities, composition, and inverses) and accurately sketch and interpret graphs using transformations and key features.
- Students will identify and analyze the key characteristics of polynomial and rational functions, including zeros, asymptotic behavior, end behavior, and discontinuities, and apply these concepts to problem solving and modeling.
- Students will solve equations and applications involving exponential and logarithmic functions, including growth and decay models, and interpret solutions in applied contexts.
- Students will evaluate and apply trigonometric functions using the unit circle, solve right and oblique triangle problems, and analyze trigonometric graphs and identities to model periodic phenomena.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
