Course Overview: Calculus II, a continuation of Calculus I, encompasses the study of integration of transcendental functions, techniques of integration, polar coordinates, improper integrals, sequences, and series. Must be taken concurrently with MATH 2114. Prerequisite(s): MATH 2313 Calculus I and MATH 2113 both with a grade of C or higher, or equivalent or permission by department.

Corequisites: MATH 2114

Student Learner Objectives

- Evaluate definite and indefinite integrals using the Fundamental Theorem of Calculus, substitution, and basic integration rules, and interpret integrals as accumulated change.
- Apply definite integrals to compute areas, volumes (by slicing, disks, and washers), arc length, surface area, work, and average value of a function.
- Use advanced integration techniques—including integration by parts, trigonometric integrals and substitutions, partial fractions, and improper integrals—to solve both theoretical and applied problems.
- Analyze and solve problems involving applications such as moments and centers of mass, fluid pressure and force, and other physical applications modeled by integrals.
- Select and justify appropriate integration methods to model and solve complex problems, and clearly communicate mathematical reasoning and results.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR

668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. Students' Rights
