## GENERAL INFORMATION

### DESCRIPTION

This course examines the concept of “home” as a central and contested idea within Global Anglophone Literature. Through close readings of a diverse range of literary texts, the course investigates how notions of home are imagined, remembered, constructed, and transformed across different historical, cultural, and geographic contexts. Particular attention is paid to representations of belonging, place, identity, and movement, exploring how experiences such as migration, displacement, and transnational circulation complicate and reshape what it means to call a place “home.” The term “Anglophone,” meaning “English-speaking,” encompasses writers from Ireland as well as nations of the British Commonwealth and former British Empire, allowing the course to foreground the global dimensions of literary engagements with home.

### EXPECTATIONS AND GOALS:

On completion of this course, students will:

- demonstrate knowledge and understanding of twentieth and twenty-first-century British and Anglophone literatures and the key critical issues concerning it; and
- critically read and analyze a range of texts, making note of the relationships between the texts and their theoretical, historical, and cultural contexts.

## **TRANSFERABLE SKILLS:**

Skills practiced in this class that transfer to multiple contexts and circumstances include critical thinking and reading, persuasive writing, analytic writing, synthesis of information, and collaboration.

## **HOW TO SUBMIT YOUR WORK**

Submit assignments electronically to **Blackboard**. Be sure to familiarize yourself with the **Blackboard** system prior to submission/posting, and contact me if you have questions. Use **MLA** format.

Our goal in engaging with these texts is not to adopt the authors' viewpoints, but rather to explore what they believed and understand their perspectives. ## Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any

student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

## The Six-Drop Rule

drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

## Students' Rights and Responsibilities
