**Course Objectives:** The objective of the course is to understand the modern tools and methods used in economic decision-making and apply those in various business set up. The course is designed for the students with limited background in economics or business. The focus of the course is on the study of macroeconomic variables, monetary and fiscal policy, and other economic issues.

**Prerequisites:** None

**Student Learning Outcomes:**

After successful completion of this course, students will be able to: (1) understand, interpret, and evaluate the key macroeconomic variables, such as output, inflation, and employment; (2) how monetary policy works to steer the economy on its right path; (4) how fiscal policy set by the government could be used to stimulate the economy. The learner outcomes will be assessed by quizzes and exams.

### Course Requirements

You must complete all MindTap home-works by 11: 59 p.m., May 09. They can be located in the Course Content on Blackboard. Please make sure that you check all folders (including **Getting Started: Key Tools for Learning Success**) in each of the chapters to complete these home-works in order to receive full credit (they are marked as COUNTS TOWARDS GRADE). **The total possible points for home-works are 406. Note that before the deadline, MindTap shows your grades based on the number of home-works completed, not all possible points (406).** You will also find a host of other activities that will not be graded, but I strongly encourage you to complete those as well.

**Blackboard shows the unweighted raw data of home-works and exams. To find out your standing anytime during the semester, you need to apply the proper weights to those row scores. If you have any questions, you should immediately contact me.**

#### **Course Delivery Method:**

Since this is an online course offered in an asynchronous format, there will not be any scheduled classes. I advise that you follow the recommended schedule on reading the chapters to timely prepare yourself for the exams. You can also work on the slides that I already posted on the Blackboard. Note that MindTap has important activity-based resources that you can follow to understand the materials. **They are really very helpful!** If you face any trouble, I urge you to contact me by email with detail information. I will then send you a Zoom link to have a live interaction at mutually agreeable time.

#### **Make up and Late Assignment/exam/quiz policy:**

Please note that I will not be able to reset the home-works if you miss any. If you face any technical problem in completing the home-works, you must have to inform me before the deadline, otherwise I will not be able to consider any complain. You must have to attend Exam-3 to pass this course. It is the responsibility of the students to contact the instructor and provide legitimate reasons if you miss Exam-3. 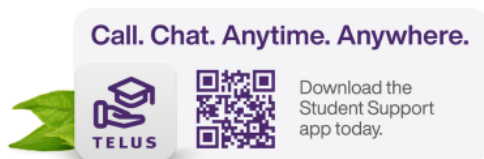

**Financial Aid and Verification of Attendance:** According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
