Course Description

An examination of the role of culture in the development and validation of psychological theories. Critical discussion of the application of Western theories to other cultural groups, including ethnic minority subgroups. Topics may include identity formation, cognitive and personality development, social and organizational behavior, intergroup relations, psychological assessment, and mental health. Missed / Late Homework Policy

Assessment and Evaluation

Discussion Boards – 20 points

Review Days – 25 points

Exams – 100 points

These assessments will delve deeper into your comprehension, requiring you to apply theoretical knowledge to practical scenarios and analyze research findings. You'll be challenged to articulate your understanding clearly and concisely, demonstrating your ability to think critically about the subject matter.

- **Logistics:**

Arrive on time. All exams end when class time ends. The exams are designed to be completed in 50 minutes. Manage your time effectively. Unanswered questions will be considered incorrect. The assessment schedule is provided on the first day of class. Make-up assessments are only granted for documented emergencies and may be oral. Make-up assessments should be completed within one week of the original assessments date, if possible.

Group Project Presentation – 100 points

Students will engage in a group project involving experiential learning through the lens of Culture & Psychology. The groups will prepare and present their experience orally to the class. More details will be discussed in class.

Final Project Reflection – 100 points

In addition to the group presentation, each student will submit an individual written report of their experience in greater depth. Your report will include a clear summary of the study, an explanation of its design and methodology, an interpretation of its statistical results, and a critical evaluation of strengths, limitations, and broader implications. You will also reflect on how ethical guidelines were addressed and identify the study's variables. Reports should be well-written using APA style and demonstrate a strong comprehension of course content.

All assignments MUST be submitted on the desktop web version of the application. The mobile app and often mobile web versions DO NOT submit properly.

If you have trouble with Blackboard automatically populating your dashboard or syncing to your calendar, please contact me immediately to correct this.

Additional Readings (IF ANY)

Links to additional readings (if any) will be provided to you through Blackboard. The deadlines for completing the additional readings will be added to the syllabus.

Additional readings will be selected because I believe that the readings will help you to expand your knowledge in a particular area or to broaden your general understanding of a topic.

These will usually be university-level readings, although some may be from popular media sources.

You will also be finding additional readings on your own to complete the course project. All research papers that you find through academic research are expected to come from peer reviewed journals (unless otherwise stated in the assignment).

Note: ALL written assignments are due as **MS Word docx** files unless otherwise noted.

Reading Note

You are expected to read each chapter and other assigned (if any) articles BEFORE class in which the topics will be covered.

1) Other Assignments: Other assignments in this class may include, but are not limited to, quizzes, discussions of various styles (including fishbowl, open, and prompted), reaction papers, blog/journal, video presentations, statistical calculations, homework, and essays. Points for these assignments are listed on the course calendar. Details for assignments are released through Blackboard. See syllabus for due dates / times.

Assignments will be released through Blackboard. It is your responsibility to check Blackboard to get the assignments before they are due. It is recommended that you check Blackboard at least once per day. If you have any questions about the assignments, you **MUST** ask me **BEFORE** the assignment is due. Not completing assignments because you had questions is not an excuse for not turning in assignments.

All assignments are mandatory, and are **due through the Blackboard assignment link**. Do not turn assignments in through email. Blackboard will time / date stamp your submission. Please ensure that you are submitting your work within the accepted timeframe.

****All written assignments are expected to be in proper APA format.** It is highly recommended that you invest in a 7th ed. APA manual so that you can get the cover sheet, in-text citations, reference page, etc. correct! There are also free online resources, including the workshops that you will use for the library assignment, the **Purdue OWL website** and **apastyle.org**.

All written assignments must be submitted as **MS Word docx ONLY**.

Attendance Attendance will be recorded in an effort to comply with federal regulations regarding financial aid. If the last date of attendance is unknown, the class day after the last assignment you completed will be reported. Attendance will not count as a portion of your grade.

Note: You must be *active* in the class within the first week. Failure to complete the assignment for the first week of class may result in a loss of financial aid, and may result in being dropped from the course.

Participation Participation is related to attendance. While there is no “grade” for participation in

class, participation affects your grade. Studies show that students who are actively engaged in learning have higher grades than students who do not participate. Of course, there may be many reasons for this, including lack of preparedness or lack of comprehension by those who choose not to participate. That said, participating allows you to have a deeper understanding of the information, it allows you to ask questions about information that is confusing to you, so that you can get clarification, and it allows me to get to know your strengths and weaknesses (which I can then address).

Note: Do above and beyond the minimum work required to just earn a grade so that you can really learn the material. If you are struggling with ideas in the class, message me and let me help you!

Blackboard Blackboard is important. All class information- PPTs, provided outside readings, web links, video links, assignments, announcements, etc.- is available through Blackboard. You should make a habit of checking Blackboard often to ensure that you are up to date on class information.

Throughout the semester your assignments (written assignments, exams, quizzes, etc.) are due through Blackboard. When you are submitting a written assignment through blackboard, you MUST submit it through the Blackboard assignment link.

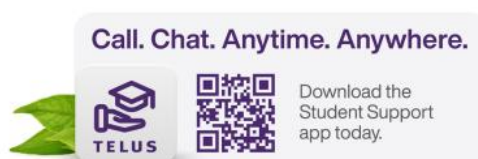

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. Each student shall have the right to participate in all areas and activities of the University, free from any form of discrimination, including harassment, on the basis of race, color, national or ethnic origin, religion, sex, disability, age, and pregnancy/parenting or veteran status in accordance with applicable federal and state laws.
3. A student has the right to personal privacy except as otherwise provided by law, and this will be observed by students and University authorities alike.
4. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

Students' Responsibilities

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, [Student Code of Conduct](#), on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
4. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning.
5. A student has the responsibility to check their university email for any updates or official university notifications.

We expect that students will behave in a manner that is dignified, respectful, and courteous to all people, regardless of sex, ethnic/racial origin, religious background, or disability. Conduct that infringes on the rights of another individual will not be tolerated.

Students are expected to exhibit a high level of honesty and integrity in their pursuit of higher education. Students engaging in an act that violates the standards of academic integrity will find themselves facing academic and/or disciplinary sanctions. Academic misconduct is any act, or attempt, which gives an unfair advantage to the student. Additionally, any behavior specifically prohibited by a faculty member in the course syllabus or class discussion may be considered as academic misconduct.
