Course Description

Thesis hours involve work on a thesis with an advisor. The course will be repeated until the thesis is finished and defended.

- **Email:** Please only use official university e-mail and include the course, section, and full name in the subject line. Please do not use Blackboard messages. I will generally respond within 24 hours of your email. If you do not receive a reply after 24 hours, please email again and/or follow up directly with me in class or during office hours (see above). I will not be available by email during the weekends. Any emails received during the weekend will be replied to on the subsequent Monday. Please plan accordingly. Especially when it comes to clarifying assignment instructions and/or submission requirements. In all communications, please be professional in your tone and specific in your message (i.e., avoid informal correspondence styles like text messaging which lack appropriate punctuation and capitalization). Your correspondence **MUST** include the information specified above. If you send an email without sufficient information, I likely will not reply or may reply asking for clarification about your inquiry (this can result in an unnecessary delay). Please begin a new email thread instead of responding to older

emails if you are beginning a new conversation unrelated to the previous email (this helps minimize confusion caused by chain replies).

- **Office Hours:** I will be available in my office (STEM 249B) to meet during office hours (see above) or by appointment. Office hours are dedicated to interacting with and providing students assistance regarding coursework. An appointment is not necessary to attend these hours, but interactions are limited to a first-come, first-served basis. If there is a specific assignment/materials or topic you want to discuss, providing advance notice will allow me to have these resources ready. If students cannot meet during these times, an alternative time can be requested via email, and I will do my best to try to accommodate students accordingly. For discussions involving more personal and/or sensitive information, some form of advance notice is recommended.

Assessment and Evaluation

Specific tasks and expectations will vary depending on each student's research focus, the stage of their thesis project, and the activities of the research lab during the semester. However, in general, students enrolled in this course are expected to engage consistently in the following activities:

- **Weekly Check-In:** Students are expected to meet with the professor at least once per week. These meetings will be used to establish weekly goals, review progress from the previous week, and/or troubleshoot challenges.
- **Lab Meetings:** Students are expected to attend and actively participate in lab meetings throughout the semester. The content and structure of lab meetings will vary based on ongoing research needs. Students may be asked to present updates on their thesis progress, lead workshops, or provide feedback on their colleagues' work.
- **Research Design:** Students are expected to develop expertise in their chosen area of research and develop a thesis project that can be empirically tested using well-designed methodology. This includes, but is not limited to, conducting literature reviews, developing research questions and hypotheses, selecting appropriate methods, and preparing materials for study implementation. When applicable, students are also responsible for developing training materials and procedures for research assistants.
- **Data Analysis:** Students are expected to develop a data analysis plan that aligns with the thesis design and research questions. This includes, but is not limited to, preparing coding schemes, cleaning and managing data, conducting analyses, and interpreting results.
- **Writing:** Students are expected to make consistent progress on thesis writing appropriate to their project stage. This may include drafting thesis sections (e.g., introduction, methods), preregistrations, and IRB protocols, as well as revising and integrating feedback. Any writing necessary for the successful completion of the thesis falls under this category.
- **Professional Development:** Additional expectations may include mentoring undergraduate research assistants, preparing conference submissions, delivering research presentations or guest talks, and engaging in other scholarly or professional activities directly related to the thesis project.

Due to the individualized and evolving nature of thesis work, this course does not use a traditional point-based grading system. Final grades will be based on the student's effort, engagement, and fulfillment of agreed-upon tasks, as determined collaboratively by the student and the professor over the course of the semester.

Course Schedule

Except for weekly check-ins, lab meetings, and other meetings scheduled as needed, most thesis work will be completed remotely. Students are expected to dedicate at least 10 hours per week to advancing progress on their thesis.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. The Six-Drop Rule

Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
