Course Description

This course trains graduate students in core experimental and computational research methods used in modern cell and molecular biology. Students will critically analyze primary technique-driven research articles, perform sequence analysis and phylogenetics, and gain hands-on experience in fatty acid methyl ester (FAME) analysis for lipid profiling. The course emphasizes experimental design, data interpretation, and methodological rigor, preparing students for independent research.

Learning Objectives

By the end of the course, students will be able to:

1. Critically evaluate **methods sections** in primary research articles
2. Select appropriate molecular and cellular techniques for research questions
3. Perform **multiple sequence alignments and phylogenetic analyses**
4. Interpret bioinformatic outputs in a biological context
5. Design and execute **FAME analysis** for lipid extraction and profiling
6. Integrate computational and experimental data into a cohesive research narrative
7. Communicate methods and results clearly in written and oral formats

Topics that will be covered (week wise)

All topics will be covered as discussion based and/or experiment based. Pre-readings of instructor presented materials will be needed. There will be no final exam for this course. Mid-term and final grade will be cumulative based on each week's performance, discussions, presentations and mini proposal development

2. Identification of key lipid genes and how their manipulation will be biologically relevant
