COURSE DESCRIPTION

Spanish Language Studies IV is a fourth-semester course that will focus on the development of reading and academic writing abilities and intercultural competency to develop bilingual and bicultural literacy. This course is also for students with a cultural connection to heritage language speech communities or who have achieved proficiency from study in previous courses. In addition to scaffolding skills that students already have, in this class they will expand their ability to describe abstract and hypothetical situations. Students will also examine formal and informal contexts of language use in speaking and writing. By studying the cultural and historical background shared by students as part of the program, students will develop an increased critical awareness of Spanish language speech communities. The course emphasizes the role of students as storytellers, and the narrations and narratives created by generations of skilled Latin American people about their knowledge and culture. Students will read, interpret, historical and cultural products from Spanish-speaking countries and produce their own multimedia narratives about the own communities.

Goals

- Maintenance of the language
- Understanding tensions and overlaps between local and standard registers
- The expansion of bilingualism and translanguaging
- The development of academic skills in the heritage language
- Positive attitudes toward both the heritage language and its various dialects and cultures

- The development of cultural sensitivity
- Development of critical language awareness
- Development of multiliteracies

Student Learning Outcomes (on syllabi and for assessment)

1. Interpersonal Communication: Students can exchange information on a wide variety of familiar topics in which the students use appropriate vocabulary to describe their daily lives, narrate events in the past, describe future events, and present a simple hypothetical situation with some degree of ease and confidence. Students will record a podcast.
2. Written expression: Students can produce writing in the target language that state their viewpoint about familiar topics and give some reasons to support it, using sentences and series of connected sentences.
3. Interpretive listening: Students can usually understand the main idea and flow of events expressed in various time frames in conversations and discussions.
4. Interpretive reading: Students can usually follow the main message in various time frames in straightforward, and sometimes descriptive, paragraph-length informational and fictional texts.
5. Critical cultural and language awareness: Students can recognize and explain some of the issues facing bilingual communities in accordance with the instructor's expertise and articulation with previous and subsequent courses.

Communicative Functions to consider

- Providing suggestions in which the speaker is included
- Discussing options, probabilities, or capabilities of doing something
- Evaluating the results of an action or an event
- Warning someone / discouraging someone from pursuing a course of action
- Interviewing people, formulating questions.
- Discussing a literary text, audiovisual production and visual products and multimedia content

- Expressing moral, intellectual, and social concerns

COURSE POLICIES

Course Prerequisite

Spanish 2315 is the second intermediate level course designed for students who are bilingual and/or have taken SPAN 2313 at A&M-San Antonio. The course is designed for bilingual and second language learners of Spanish. The course focusses on developing grammatical, conversational, and listening skills in a positive and culturally relevant setting. Prerequisite: Placement by exam or departmental approval, or successful completion of SPAN 2313.

Students wishing to enroll in Spanish must take the A&M-SA Spanish Placement Exam (SASPE) for appropriate placement.

Attendance

Attendance and participation are mandatory. You must come to class **every week** and you must be ready to participate actively in class discussion as well as small group activities. Attendance factors into your participation grade.

- You are allowed **two** "grace" absence, which cannot be taken on a day when you are scheduled to make a presentation or a report. For each subsequent absence 2% will be deducted from your final grade.

- Missed work can only be made up if you have valid documentation. Legitimate excused absences include the following: verifiable confining illness, serious verifiable family emergencies, subpoenas, jury duty, and military service. It is your responsibility to notify the instructor of any excused absences as far in advance as possible. Work must be made up in a timely manner (e.g. before the next scheduled evaluation).
- Documentation for excused absences must be presented as soon as possible. No documentation will be accepted after the last day of regularly scheduled classes.

Class participation

This course is conducted in Spanish. Students are expected to participate (group discussions and assignments) in Spanish. This is a class for YOU to feel confident producing the Spanish you may have heard before as you were growing up. Taking risks in Spanish is crucial for you to build up your oral skills. The use of Spanish is expected in every activity in the class with the instructor and classmates, but the class also welcomes **translanguaging**. You are expected to attend all classes, read the material before class, and participate actively in classroom activities. **You will be expected to participate in class activities and discussions, to continue to improve your speaking fluency.** A grading rubric for oral participation will be provided. Keep in mind that if you are absent, you will receive no participation points for that day.

Technology Use

In general, the use of laptops, tablets, and cell phones for personal use during class is not allowed. Exceptions will be made when talking about discussion posts in class or accessing BLACKBOARD for course materials. Please turn off and put away these devices during class lectures, discussions, and exams. These devices can be distracting to you and others in the class and can prevent you from focusing on course content and participating in class discussions.

No Use of Generative AI Permitted

SPAN 2315 assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Assignment Due Dates

Due dates are firm. Work is due at the *beginning* of each class period (unless specified otherwise) and late work will not be accepted. **Coursework turned in late will receive zero points for the assignment.** We will make exceptions for university-excused absences and unavoidable circumstances (e.g., deaths, personal/family illness and emergencies) with written verification. *All assignments need to be uploaded onto BLACKBOARD.*

Make-up Exams and Presentations

If you are not in class on the scheduled day to take an exam or to participate in the group presentation you will receive a score of zero. Make-up exams and presentations will be arranged for university-excused or unavoidable circumstances (e.g., deaths, personal/family illness, and emergencies), but *only* with written verification. Proper documentation must be submitted within 72 hours of your absence. I also ask that you inform us of these types of situations at least 24 hours in advance.

Based on four, interrelated components:

Participación (150 pts.): Participation is a fundamental part of this course. Please read ahead, practice the vocabulary for the week so you are able to actively contribute to the class. No hay la posibilidad de *make-ups* en el caso de las actividades de clase. (Please note: *This is not merely an attendance grade, but rather a global assessment of the quality of your participation in class activities.* You are expected to contribute to all group activities and class discussions.) Some activities include discussions about multimedia, creative writing assignments.

Tareas y lecturas (300 pts.) There will be *Tareas* on Blackboard covering the grammar, vocabulary, and spelling topics studied in each unit. There will also be reading assignments on Perusall, a social reading platform embedded in Blackboard. Responses to the readings must be typed directly in Perusall and should not be copy-pasted

Midterm Exam (100 pts) & Final Exam (150): There will be a midterm and a final exam that will include the material covered in each unit: *Manual de discusión y reflexión* and *Manual de práctica*. Exam dates are specified in the course calendar.

Oral Presentation & Visuals: (100 pts.)

Students will prepare a presentation exploring the changes of a chosen urban space and its community in Spanish. The oral presentation should include visuals of both the past and present

of the urban space (include your own photographs), videos or relevant media content is also accepted. Presentation should highlight a reflection on the significance of this particular location for the student. This assignment is designed to develop communication, critical thinking, and personal responsibility skills. The oral presentation will be evaluated individually as an oral exam, and the presentation time should be evenly distributed. The presentation should last approximately 5-7 minutes. Please refer to the oral evaluation rubric on BLACKBOARD for more details

Urban narrative (Visual and Poetic narratives)

This course will focus on students as both knowledge holders and producers, valuing their cultural backgrounds and personal experiences as vital components of their linguistic and literacy growth. Through engagement with various storytelling mediums—oral, written, visual, and digital—students will create multimodal narratives connected to their communities.

To enhance their storytelling skills, two bilingual artists from San Antonio will lead workshops in storytelling, and photography. After each workshop, students will develop their own narratives (students can reach out to the artists for feedback). Additionally, students will receive peer review and formative feedback from their instructor. The final version of students' photographs, urban narrative, incorporating both the artists' suggestions and peer feedback, and instructor formative feedback will be submitted as part of the final project. The instructor will provide additional instructions and rubrics for each submission. The assignments should primarily be written in Spanish, but limited use of translanguaging is acceptable.

Final Project (200):

The culmination of the course will be the creation of a final project consisting of three narratives: a poetic narrative or short story, a photographic piece, and a reflective essay on a meaningful place in the city with which the student has a personal connection. Students will curate these three components into a cohesive multimedia urban narrative project, which will be presented in class and uploaded digitally.

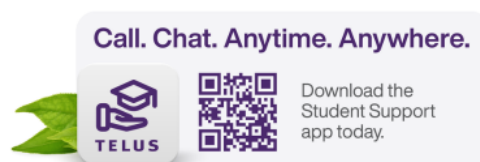

A&M-San Antonio's Title IX Coordinator can support those impacted by such conduct in navigating campus life, accessing health and counseling services, providing academic and housing accommodations, and more. The university strongly encourages all students to report any such incidents to the Title IX Coordinator. Please be aware that all A&M-San Antonio employees (other than those designated as confidential resources such as counselors and trained victim advocates) are required to report information about such discrimination and harassment to the university. This means that if you tell a faculty member about a situation of sexual harassment, sexual violence, or other related sex-based misconduct, the faculty member must share that information with the university's Title IX Coordinator (titleix@tamusa.edu, 210-784-2061, CAB 439K). If you wish to speak to a confidential employee who does not have this reporting requirement, you can contact the Student Counseling Center at (210) 784-1331 or visit them in Madla 120.

Pregnant/Parenting Students: Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable accommodations to pregnant students as would be provided to a student with a temporary medical condition that are related to the health and safety of the student and the student's unborn child. These could include maintaining a safe distance from substances, areas, and activities known to be hazardous to pregnant individuals and their unborn child; excused absences because of illness or medical appointments; modified due dates for assignments; rescheduled tests/exams; taking a leave of absence; and being provided access to instructional materials and video recordings of lectures for excused absences, if these would be provided to any other student with an excused absence. Texas A&M-San Antonio has also designated the Title IX Coordinator as the liaison officer for current or incoming students who are the parent or guardian of a child younger than 18 years of age. The Title IX Coordinator can provide students with information regarding support services and other resources. Young Jaguars can support parenting students with daycare if students meet this criteria: (1) must be enrolled in classes at Texas A&M-San Antonio in the current semester, (2) must be Pell eligible or a single parent, (3) child(ren) must be aged 3 to 12-years-old, and (4) child(ren) must be enrolled in Pre-K-3 through 6th grade.
