### **Catalog Description**

ACCT 3328. Internship in Accounting. 3(3-0)An off-campus learning experience allowing the application of accounting skills in an actual work setting. Will count towards the hours required for the CPA exam only if the internship requirements set by the State Board of Public Accountancy are met. Prerequisites: Admitted into the College of Business.

ACCT 5350. Internship in Accounting. 3(3-0)An off-campus learning experience allowing the application of accounting skills in an actual work setting. This course will count towards the hours required for the CPA exam only if the internship requirements set by the State Board of Public Accountancy are met. Prerequisites: approval of a faculty coordinator, department chair, and College of Business Dean

**Course Number and name:** Accounting Internship 3328 600 202220  
This class meets off campus. The ‘class’ occurs at the employer’s workplace.

**Prerequisites:** Completion of Intermediate ACCT 3303 and 3304

**Final Exam Schedule:** A final report rather than an exam is required for this class.

Rules for Accounting Internships are prescribed by the Texas State Board of Public Accountancy. The rules are the same for all universities.

In a nutshell, students serve an internship to perform agreed upon tasks for an employer. The employer acts as a mentor. The student performs a specific function, not just being the office gopher for example. These experiences are recounted in a weekly report to the Professor assigned to the class. These weekly reports become the basis for a semester end report by the student. In addition the employer files an end of semester report on the student.

The reports should be e mailed to the Professor at the end of each week of the internship. E mail address is the same as above, [delam@tamusa.edu](mailto:delam@tamusa.edu).

Student will report their weekly activities on the Blackboard Site in the Blog Section assigned to them. A final report will recount the activities performed and skills learned. The employer submits an accompanying final report.

**Student Learning Outcomes:** Students will be assigned a specific set of tasks by the employer. Outcomes will vary according to the task assigned. Hence outcomes may include but are not limited to

Journalize transactions

Post transactions to ledger

Prepare invoices and receipts

Reconcile accounts, inventories, payments

Identify inventory levels

### **Required Materials:**

There are no required materials per se. Materials Software, and hardware will be discussed and provided by the employer to assist in proficient completion of assigned tasks.

**Blackboard:** You will be assigned a journal. This is accessed under course content. Each week you need to post a 2350 word description of what you did that week.

**Time Expectation:** Student and employer will establish an appropriate work schedule.

**Course Requirements:**

The requirement is completion of a weekly report of 250 words describing the week's activity. A journal has been created in BB for each student to separately post their reports for ease of location and reference.

**Grading Policy:** There are no exams, quizzes, or homework. Work is assigned by the employer. The grade is assigned based on the completion of required reports

The final letter grades will be assigned as follows: Above 90%  $\Rightarrow$  A; 80 – 89%  $\Rightarrow$  B; 70 – 79%  $\Rightarrow$  C; 60 – 69%  $\Rightarrow$  D; Below 60%  $\Rightarrow$  F.

This course has a requirement of a grade of C as a minimal grade for satisfactory completion of this course.

aware that all A&M-San Antonio employees (other than those designated as confidential resources such

as counselors and trained victim advocates) are required to report information about such

discrimination and harassment to the university. This means that if you tell a faculty member about a

situation of sexual harassment, sexual violence, or other related sex-based misconduct, the faculty

member must share that information with the university's Title IX Coordinator ([titleix@tamusa.edu](mailto:titleix@tamusa.edu),

210-784-2061, CAB 439K). If you wish to speak to a confidential employee who does not have this

reporting requirement, you can contact the Student Counseling Center at (210) 784-1331 or visit them in

Madla 120.

Pregnant/Parenting Students: Texas A&M-San Antonio does not require a pregnant or parenting

student, solely because of that status or issues related to that status, to (1) take a leave of absence or

withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable modifications to pregnant students as would be provided to a student with temporary medical condition that are related to the health and safety of the student and the student's unborn child. These could include maintaining a safe distance from substances, areas, and activities known to be hazardous to pregnant individuals and their unborn child; excused absences because of illness or medical appointments; modified due dates for assignments; rescheduled tests/exams; taking a leave of absence; and being provided access to instructional materials and video recordings of lectures for excused absences, if these would be provided to any other student with an excused absence. Pregnant/parenting students are encouraged to contact the Title IX Coordinator with any questions or concerns related to their status ([titleix@tamusa.edu](mailto:titleix@tamusa.edu); 210-784-2061; CAB 439K). Texas A&M-San Antonio has also designated the Title IX Coordinator as the liaison officer for current or incoming students who are the parent or guardian of a child younger than 18 years of age. The Title IX Coordinator can provide students with information regarding support services and other resources. **Students' Rights and Responsibilities:** The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country.

#### Students' Rights

1. A student shall have the right to participate in a free exchange of ideas, and there shall be no

University rule or administrative rule that in any way abridges the rights of freedom of speech,

expression, petition and peaceful assembly as set forth in the U.S. Constitution.

2. Each student shall have the right to participate in all areas and activities of the University, free

from any form of discrimination, including harassment, on the basis of race, color, national or

ethnic origin, religion, sex, disability, age, sexual orientation, gender identity, gender expression,

and pregnancy/parenting or veteran status in accordance with applicable federal and state laws.

3. A student has the right to personal privacy except as otherwise provided by law, and this will be

observed by students and University authorities alike.

4. Each student subject to disciplinary action arising from violations of university students' rules

shall be assured a fundamentally fair process.

#### Students' Responsibilities

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, Student Code of Conduct, on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
4. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning.
5. A student has the responsibility to check their university email for any updates or official university notifications.

We expect that students will behave in a manner that is dignified, respectful, and courteous to all

people, regardless of sex, ethnic/racial origin, religious background, sexual orientation, or disability.

Conduct that infringes on the rights of another individual will not be tolerated.

Students are expected to exhibit a high level of honesty and integrity in their pursuit of higher

education. Students engaging in an act that violates the standards of academic integrity will find

which gives an unfair advantage to the student. Additionally, any behavior specifically prohibited by a

Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

**Option 3 – Broader Use of Generative AI Permitted Within Guidelines**  
Use of artificial intelligence (AI) tools, including ChatGPT, is permitted in this course for students who wish to use them. To adhere to our scholarly values, students must cite any AI-generated material that informed their work (this includes in-text citations and/or use of quotations, and in your reference list).

Using an AI tool to generate content without proper attribution qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.
