**Course Description and Material**

**Catalog Description:** A study of linear algebraic structures to include vector spaces, subspaces, bases, dimension and normed spaces. Related topics include vector geometry, orthogonality, normal forms eigenvalues, linear and special transformations.

**Prerequisite:** Any two of the following: MATH 3415, MATH 3325, MATH 3340, MATH 3370, MATH 4321, MATH 4330; all prerequisites require a grade of “C” or higher.

**Student Learner Objectives:** Upon completion of this course, you will be able to:

- Demonstrate understanding and knowledge of vector spaces, subspaces, bases, and Gram-Schmidt orthogonalization of a given basis.
- Demonstrate understanding and knowledge of lattices and different type basis reductions.
- Demonstrate understanding and knowledge of applying mathematical theory in cryptography.

9. Applications of lattice basis reduction in Cryptography

**NOTE:** This class meets twice a week. Aside from the three hours that you spend in class each week, you should devote at least another 4~6 hours to studying on your own: reading the book and my lecture notes, working out your homework assignments, and solving some extra related problems for practice etc. You are responsible for all materials/topics discussed in this class.

**Active Learning:** This course implements active learning throughout, and you are strongly encouraged to preview the teaching materials and be aware of many in-class participation and self/group study activities.

### **Course Expectations and Requirements**

**Class Attendance:** You are expected to attend classes as scheduled and be prepared to participate in discussions, in-class exercises, and problem presentations. In addition, if an unavoidable situation prevents you from being on time or if you must leave early, **please minimize class interruption.**

**Quizzes:** There will be a 5~10-minute in-class quiz at the beginning of Monday's class, covering the topics from the previous week. **No** make-up quizzes will be given, and the three lowest quiz grades will be dropped.

**Midterm Tests:** There will be two midterm tests during the semester held in regular class: one in Feb and one in April. The exact midterm test dates will be announced at least one week in advance, both on Blackboard and by email. All tests will be taken during class time.

Exams are scheduled at specific times, and you are expected to take them as scheduled. If you cannot attend an exam for a legitimate reason, please let me know (or have someone notify me if you're unable to) within 24 hours of the scheduled exam time. You will need to provide a brief explanation along with appropriate supporting documentation. If you know ahead of time that you will miss an exam, please contact me in advance so we can make the necessary arrangements. Missing an exam without following this procedure may result in a **GRADE OF ZERO.**

**NOTE:** Graphic calculators, cell phones, laptops, iPad, and any other electronic/mobile devices are **NOT** allowed in tests/exams. Once found, your tests/exams would receive **GRADE OF ZERO.** Repeated violations may be reported to the university as academic dishonesty.

**Assignments:** Please check Blackboard announcements for instructions and due dates. All homework assignments will be collected at the beginning of class on the due date. If you cannot finish every question, do your best to complete as many as possible. Start early, don't wait until the last day, as working on problems daily will help you stay on track.

You may have group/team discussions on homework assignment problems. However, you must write up the solutions on your own and truly understand the mathematics/algorithms involved. Be mindful of your academic integrity.

**Presentations/Debates:** Students will be expected to participate in class by presenting/debating problems emphasizing the most recently covered topics that are related to and complementing HWs.

### Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
