Catalog Description

In-depth combined study of algebra, trigonometry, and other topics for calculus readiness. This course meets the standards for the Mathematics category of courses under the core curriculum and addresses the following required objectives: Critical Thinking, Communication, and Empirical and Quantitative Skills.

Prerequisite: MATH 1314 College Algebra with a grade of “C” or higher, or placement

Required eTextbook and Online Homework Platform

Precalculus Essentials by Robert F. Blitzer, 6th Ed., with MyMathLab, Pearson Publishing, 2022, ISBN 9780136921745. (E-book package as part of course registration.)

Calculators

Basic scientific calculators (non-graphing, non-programmable) are permitted on quizzes and exams. A TI-30XIIS scientific calculator is highly recommended. Cell phones, graphing calculators, and online math utilities are not allowed on quizzes or exams. When appropriate, more advanced calculators and software may be used on homework assignments and during class discussion.

Student Learner Objectives:

MATH 2312 helps students develop critical thinking, communication, and empirical and quantitative skills by focusing on student understanding of key mathematical concepts required for calculus readiness to include recognizing, identifying, solving, analyzing, explaining, and appropriately modeling applicable real -world situations.

Upon completion of this course, students will:

1. Demonstrate understanding and knowledge of properties of functions from graphical, tabular, symbolic, or verbal representations.
2. Identify and apply appropriate strategies for solving equations involving algebraic, transcendental, and trigonometric functions.
3. Interpret and apply graphing techniques to algebraic and transcendental functions.
4. Compute and apply the values of trigonometric functions for key angles in all quadrants of the unit circle measured in both degrees and radians.
5. Prove and apply trigonometric identities.
6. Interpret and solve applications related to right and oblique triangles.

List of Topics

Topics to be covered include but are not limited to the following:

1. Functions and their graphs
2. Exponential and logarithmic functions, and their properties
3. Exponential and logarithmic equations with applications
4. Angles and their measures
5. Trigonometric functions and right triangle trigonometry
6. Trigonometric functions of any angle
7. Graphs of sine, cosine, and other trigonometric functions
8. Inverse functions and inverse trigonometric functions
9. Applications of trigonometric Functions
10. Trigonometric identities
11. Trigonometric equations
12. The laws of sines and cosines

13. Polar coordinates and graphs of polar equations
14. Vectors and dot product

Homework: Homework will be assigned regularly with MyMathLab (MML). All due dates are listed in MML. The exercises can be attempted multiple times in order to increase the grade. MyMathLab can be accessed through a link on the Blackboard page or directly at mml.pearson.com. Students are also encouraged to practice writing solutions and will be responsible for knowing how to write clear, justified solutions on quizzes and exams.

Quizzes/Other Assignments: Quizzes will be given weekly during class on Wednesdays (except on exam days), beginning the third week of class. Occasionally, a quiz will be posted online. There will be no make-up quizzes. Additionally, written assignments may be assigned as homework or classwork. These assignments are due when announced. There will be no make-ups for missed assignments/classwork, but 2 scores from the Quizzes/Other Assignments category will be dropped.

Midterm Exams: There will be three in-class exams during the semester. The tentative dates are February 18, April 1, and April 29. In case you miss an exam or find out that you will miss an exam, you should contact me either in person or by e-mail, at least one week in advance of the exam for non-emergency cases or within 24-hrs of the scheduled exam date for emergency cases. Any missed exam counts as a 0 unless the student has a valid documented excuse and contacts me as soon as possible after the excuse for missing the test arises. Examples of valid documented excuses are sickness documented with a doctor's note, death in the family documented with a copy of the death notice, attending university-sponsored events with a Dean's excuse, etc. Minor headaches or attending sports events (without Dean's excuse) are not examples of emergency situations.

Final Exam: In order to pass this class, students must take the final exam on May 11, 12:00 pm – 1:50 pm. The exam will cover topics from throughout the semester. Final exams cannot be rescheduled or missed (for dire and unforeseen medical or family emergencies, students must consult with me).

Class Policies and Expectations

The following policies and expectations have been established for this course to create a productive learning atmosphere for all students. Please bring any concerns you may have to my attention.

1. Students are expected to arrive and be ready to start class on time and stay for the entire class period. Please refrain from leaving during class or packing up belongings early. If you know ahead of time that you will need to leave class early, please inform me before class. If you need to leave suddenly during class, please follow up with me by email after class.
2. Students are expected to participate in discussions, in-class exercises, quizzes and problem presentations. During lectures, class discussions, or group discussions, students should give their attention to the speaker(s) and contribute to the conversation. Students can earn up to 5 points (added to exam scores) based on their level of participation.
3. The use of phones or other electronic devices for non-class related activities is not allowed. Students may use laptops or tablets for note-taking and may also use assistive technology and record, but not as a substitute for note-taking. If a student needs to remain in phone contact with others outside of the classroom due to an ongoing situation, please notify me in advance. In such circumstances, it may be better to be absent from class.
4. Please refrain from bringing food or drinks to class. If needed, water or small snacks are permitted as long as they are not a distraction (not noisy, fragrant, messy, etc.).

Students unable to follow these policies will be referred to the Dean of Students and/or asked to drop the class.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to

the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

The Six-Drop Rule

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
