Course Information

Catalog Description

Study of the concepts of sets, functions, numeration systems, number theory, and properties of the natural numbers, integers, rational, and real number systems with an emphasis on problem solving and critical thinking.

Prerequisite: MATH 1314 College Algebra or equivalent

Textbook: Online access code for Long, DeTemple, Millman, Mathematical Reasoning for Elementary Teachers (7th ed.), Pearson, ISBN-13: 978-0321900999 with MyMathLab

- You will automatically be billed directly for your access code to your student account. See instructor if you choose to opt out.

Calculators: A scientific non-graphing, non-programmable calculator is required; TI-30XIIS is recommended. No cell phone or graphing calculators will be allowed on exams, and online math utilities (e.g., Desmos) are also not allowed.

Student Learning Outcomes

1. Interpret and apply Venn diagrams, elementary set terminology and functions in solving problems and in representing mathematical relationships.
2. Demonstrate an understanding of the structure of our base-10 system and various other numeration systems including positional and additive systems.
3. Demonstrate an understanding of elementary number theory and its application to arithmetic and problem solving.
4. Demonstrate standard arithmetic algorithms.
5. Relate the course content to the teaching and learning of mathematics in the elementary school classroom.

MATH 1350 helps students develop Critical Thinking, Communication, and Empirical and Quantitative Skills by focusing on student understanding of essential mathematical concepts for secondary teachers to include recognizing, identifying, solving, analyzing and explaining applications in elementary educational settings.

Class policies and expectations

Class Attendance

Students are expected to attend lectures. Be aware of what has been covered in every class, including any announcements and course policy changes made in class. Announcements and changes will also be communicated through Blackboard. You are welcome to ask questions during my office hours; however, it is your responsibility to learn the material.

Midterm Exams (40% total)

There will be two proctored midterm exams during the semester and one final exam. In case you miss an exam or find out that you will miss an exam, you should contact me either in person or by e-mail, at least one week in advance of the exam for non-emergency cases or within 24-hrs of the scheduled exam date for emergency cases. Any missed exam counts as a 0 unless the student has a valid documented excuse and contacts me as soon as possible after the excuse for missing the test arises.

Examples of valid documented excuses are sickness documented with a doctor's note, death in the family documented with a copy of the death notice, attending university-sponsored events with a Dean's excuse, etc. Minor headaches or attending sports events (without Dean's excuse) are not examples of emergency situations .

Final Exam (30%)

To pass this class, students must take the comprehensive final exam scheduled during Finals Week. The exam will cover topics from throughout the semester. Final exams cannot be rescheduled or missed (for dire and unforeseen medical or family emergencies, students must consult with me). The proctored final exam will be held in-class on the date listed above.

Quizzes and labs (20%)

A combination of group and individual quizzes will be given throughout the semester during the recitation. Your lowest quiz or lab grade will be dropped. There will be no make-up quizzes or labs.

Online homework (10%)

Homework will be assigned regularly with MyMathLab (MML). All due dates are listed in MML. The exercises can be attempted multiple times to increase the grade. MyMathLab can be accessed through a link on the Blackboard page or directly at mml.pearson.com. You will need an access code that has been sent to you via Brytewave. Please check your student email OR look for the Brytewave link in your Blackboard course to find your access code. Read the announcements in Blackboard for all instructions.

Class rules

1. Regular participation and attendance is critical in this class! Enrolling in a college-level math course means a college-level workload. Your instructor may give unannounced assignments during class.
2. Please do not ask me to extend the due dates. Work ahead on the assignments instead (remember... if something can go wrong, it will).
3. If you need additional help, please ask! Your instructor is available to help, and students also have access to free tutoring through Jaguar Tutoring in the ALC, located in the Central Academic Building, second floor. I will be available during office hours or by appointment.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Jaguar Writing, Language, and Digital Composing Center (WLDCC)

The Six-Drop Rule

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
