



## US HISTORY 1302: US History Since 1865

### Course Description

History 1302 is a United States history survey course that begins with an examination of the significance of the American Civil War and its aftermath. It continues chronologically and thematically through the Cold War and liberation struggles of the 1960s and 1970s. This course is designed to provide students with a foundational understanding of United States history during the timeframe addressed. It also seeks to promote critical and analytical engagement with the subject matter conducive to making sense of the past in relation to the present and formulating constructive responses to the challenges of our time.

Major topics addressed: The potentials and defeat of Reconstruction, westward expansion, including experiences among Native Americans and in the Texas borderlands, the New South, the Gilded Age of industrial capitalist expansion, labor wars and the class struggle, the Progressive Era, the advent of the US overseas empire, World War I, including the war on civil liberties at home, the Great Depression, New Deal Liberalism, World War II, Post-War Liberalism ("the good old days"), the rise of the National Security State and Military Industrial Complex, the Cold War, at home and abroad, the Black Freedom Struggle and liberation movements associated with Latino Americans, Native Americans, women and the working class, and the contested nature of developing twentieth-century conservatism (paleoconservatism versus neoconservatism).

### Learning Outcomes

Upon successful completion of this course, students will be able to:

1. Critically analyze primary and secondary source evidence to construct an argument.
2. Develop analytical writing skills.
3. Analyze and discuss the major historical, social, political, economic, cultural, and global forces that mark this period of United States history.
4. Analyze and discuss how North America was imagined, and what it meant, to a diversity of people during different moment of early American history.

5. Analyze and discuss North America/United States as a part of global history.

## Course Readings

You do not need to purchase a book for this course. All course readings and assignments will be provided in our Blackboard course shell.

## Instructor

I am Mindi Sitterud-McCluskey. I teach history courses at Texas A&M San Antonio, the University of the Incarnate Word and the University of Arizona. I earned my doctorate degree at the University of Arizona and my master's degree at Boston College, with specialties in economic history, labor and working-class studies, slavery, social movements, transnational migrations, and the human experience of American foreign policy. The courses I teach reflect these specialties and my interest in the lives of ordinary people.

## What to Expect: Hybrid Modality

Hybrid courses are intended to address the same subject matter as non-hybrid courses of the same title and level. They must also entail a comparable workload of learning activities and assessments. As a hybrid course, we will meet on campus once a week for lecture and discussion. Attendance is required and graded. Students will then be expected to complete a recorded lesson and additional homework assignment on their own before the beginning of the next on-campus meeting (one week). The recorded lessons cover material that would be addressed by a second weekly meeting if this course was not hybrid. The homework assignment is a standard weekly assignment required of all modalities. As with my non-hybrid and online courses, this course also requires the completion of three online exams and a final paper.

## Learning Activities and Assessments

### In-Class Lectures & Lecture Guides

Core historical content and context are conveyed through interactive powerpoint lectures. Students are expected to attend class, take notes, and participate in discussion. To facilitate note-taking and discussion, lecture guides are provided (uploaded in Blackboard). These lecture guides are not graded assignments. Students are free to pursue their own note-taking methods if they choose

- Lecture Guide Benefits: Although the lecture guides are not assigned, there are benefits associated with putting a genuine effort into completing them. 1). They are intended to narrow the content discussed in lectures to a limited number of essential points and areas of consideration, 2). They can be used while taking the three unit exams, 3). They could be an aid in the composition of the final paper, and 4). Those who complete all of the lecture guides can submit their collection for extra credit at the end of the semester.
- Lecture Guides and Absences: Students who must miss class due to a recognized school commitment, such as participation in a school athletic event, military duty or physician-verified sickness/injury can receive attendance points by using the powerpoint slides or recorded lesson associated with the class meeting that was missed to complete the corresponding lecture guide. The completed lecture guide should then be emailed to me with the date of the absence and any relevant documentation. These materials are posted in Blackboard each week. This requirement is meant to assure that an absence is followed by a review of the material covered in class during the absence and, therefore, does not contribute to a student falling behind or performing poorly on

an assessment. Attendance points for absences that fall outside the above-mentioned categories can also be earned by following the same process of completing the lecture guide for the lesson missed and emailing the completed guide. However, such cases are limited to two absences.

### Weekly Hybrid Assignments

Each week, students are expected to complete one hybrid lesson that covers material typically addressed by a second weekly class meeting. Students may choose to listen to a recorded lesson or read lesson slides. As they do so, they are expected to answer a series of questions. These questions should be uploaded in Blackboard and submitted before the start of the next weekly meeting.

### Weekly Homework Assignments

Each week, students will be expected to complete one homework assignment (in addition to the hybrid assignment). Most of these assignments take the form of documentary films, primary resource assessments, and readings. Students are required to complete & submit questions associated with these homework assignments. These questions should be uploaded in Blackboard and submitted before the start of the next weekly meeting.

### Unit Exams

Three online unit exams assess learning and engagement regarding in-class lessons, hybrid lessons, and homework assignments. Each exam is to be completed outside class via Blackboard. No more than half credit will be awarded for late exams.

### Final Paper

At the end of the semester, each student is required to submit an essay in response to specific prompt, requiring the integration of course materials and the application critical thought processes. This essay does not constitute a research paper. Rather, students will be primarily assessed according to a demonstrated ability to respond to the prompt by drawing upon & critically analyze specific course themes and materials, including weekly assignments, lectures and class discussions. General requirements:

- 5-6 pages
- Typed, double-spaced
- 11-12 pt font

## **Classroom Policies**

Participation and Courtesy: Class discussion is an important part of this course, and we will not always agree. All points of view are welcome, as long as they are informed (meaning, you have done the required assignments for class) and are not deliberately discriminatory or demeaning of other students. As we engage in the material and in conversation with each other, we must remember to do so respectfully and constructively.

**Electronic Devices:** Cell phones and earbuds should be muted and put away at the beginning of class. Laptops are permitted as long as they are being used for class purposes. Violations of these policies will result in becoming dismissed from class and losing attendance points.

**Attendance:** Students are expected to attend all on-campus sessions. The material discussed and presented in class is a vital part of the course, needed to complete additional learning activities and assessments. In cases where attendance is not possible, students can have up to 2 class absences excused by completing and submitting the lecture guide which accompanies the lecture/s missed. This process can be repeated without such limitations for those with school excused absences, military duty and physician-verified illness/ injury (see “Lecture Guides and Absences” for more information)

**Roll Call:** Because attendance is graded, the roll will be called at the beginning of class. Students should make a habit of being to class on-time. If lateness cannot be avoided, it is the student’s responsibility to speak with the professor promptly after class to request attendance points. Excessive or significant lateness may result in a loss of attendance points.

**Late Work:** Due to in-class discussion needs, no more than half credit will be awarded for late exams and assignments. Exceptions can be made under certain circumstances (please speak with professor)

**Email Communication:** Email communication is welcome. All emails should include your name and the specific course in which you are enrolled (“Monday 12:30 class,” for example). This information will facilitate the process of accessing information about grades and attendance.

**AI and Plagiarism:** All written work must be the product of student engagement with learning activities and analytical processes. Due to the distinct, thematic approach taken by this course and assessment requirements which stipulate that course materials be clearly drawn upon, AI tools and keyword internet searches will likely prove counterproductive and insufficient. Moreover, assignment submissions found to be AI generated or lifted from another source will be denied credit and might put the student at risk of university protocols for plagiarism, including dismissal.

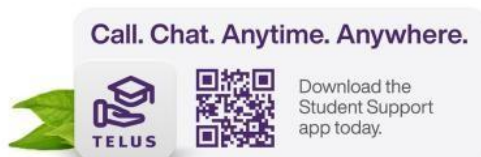

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
