Catalog Description

This course will be an examination of nonverbal communication. The various areas of nonverbal behavior in human communication will be analyzed.

Course Objectives

- To acquaint students with the basic elements of nonverbal behavior
- To examine the various aspects of nonverbal communication in different settings, such as interpersonal, small groups, and public communication.
- To acquaint students with the theories that concern nonverbal communication.

Attendance

Each student is expected to be present for all class meetings. Attendance will be taken at the beginning of class each day. If you arrive after attendance is taken, it is your responsibility to make sure your attendance is recorded by the end of the class session. Each unexcused absence will result in a penalty of 5 points per absence over 3 deducted from your final attendance grade. Three late arrivals have the same penalty as one absence. Don't be late! If you participate in University-sponsored activities (e.g., intercollegiate sports), you must check with the instructor for appropriate documentation before you are absent. Students are responsible for all missed work.

Make-Up Assignments and Examinations - If you miss an exam or activity, it must be for one of the following types of reasons: death in the family, severe documentable personal illness, etc. If you have an unexcused absence on a day you are scheduled to make a presentation or take a test, you cannot make up that presentation or test. Additionally, because of time constraints, the instructor may elect not to grant make-up exams for any reason. In order to take a make-up examination, you must submit verifiable documentation to your instructor. All make-up exams must be given to qualified persons within 2 weeks of the missed test. In-class activities cannot be made up for any reason.

Assignments

Abstracts: Each student will be required to abstract four journal articles that concern some aspect of nonverbal communication studied in class. The journals must be accepted Communication Studies journals. Each abstract must be typed, 1 to 1 ½ pages, with 1" margins and no more than 12-point font (Times Roman or Courier New). The summary should be in single-spaced format.

Each abstract should contain the following:

- Student name
- APA citation for the article
- Brief description of the article
- Article conclusions or research findings
- Application of findings
- Personal evaluation of the article

Presentation

Select one topic dealing with nonverbal behavior. Provide a brief report on that topic, outlining the basic details of the nonverbal area, and focusing on the application of the topic to a specific setting. For example, the use of nonverbal immediacy behavior in superior/subordinate communication. This is not a full research presentation; therefore, you are granted more leeway in your personal interpretations of the topic. However, it must be logically sound and supported by the literature wherever possible. Further explanation will be given at a later date.

Special Considerations

Any student who, due to a disability, may require special arrangements to meet course requirements should contact the instructor as soon as possible to arrange the necessary accommodations.

Student Conduct

Appropriate conduct is essential to the effective functioning of the University. again, 10 points will be deducted from the FINAL GRADE. No one should be calling or texting you during class. If you have an emergency and need to answer a call or text during class, please communicate that with me prior to class starting.

Additionally, ***I expect full academic integrity with every assignment:***

- I have a ZERO tolerance policy on cheating and/or plagiarism of ANY kind, including the use of AI or Chat GPT to complete your work.
- Academic integrity is a fundamental principle in higher education. The use of AI without proper attribution or ethical considerations constitutes academic dishonesty, which is a violation of the TAMUSA Academic Integrity Policy. Using AI to complete your assignments is not permitted and may be subject to failing the assignment, this course, and/or disciplinary proceedings.
- I utilize TurnItIn software for our submitted assignments, so any student found plagiarizing, cheating, or utilizing AI is subject to failing the assignment, course, and/or other disciplinary actions. This is non-negotiable.
- The best way to avoid plagiarism is to *properly* cite the sources you utilized with the appropriate citation method (using APA format) every time, and to include a References or Works Cited page. Remember, you must also put the information you gathered from your sources into your own words- *you CANNOT copy and paste from a source directly into your paper and claim it as your own*. We will discuss this thoroughly in class, including proper citation methods and what constitutes plagiarism.
- AI or Chat GPT may ONLY be used with instructor permission on certain in-class activities. Using AI or Chat GPT for anything else can lead to an automatic zero and is subject to other disciplinary actions as is deemed by university policy. I WILL KNOW if you have not used your own words!

Option 1 - No Use of Generative AI Permitted

[Insert Course Number] assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Option 2 – Use of Generative AI Permitted Under Some Circumstances or With Explicit Permission

There are situations and contexts within this course where you may be asked to use artificial intelligence (AI) tools to explore how they can be used. Outside of those circumstances, you should not use AI tools to generate content (text, video, audio, images) that will end up in any student work (assignments, activities, discussion responses, etc.) that is part of your evaluation in this course. Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Option 3 – Broader Use of Generative AI Permitted Within Guidelines

Use of artificial intelligence (AI) tools, including ChatGPT, is permitted in this course for students who wish to use them. To adhere to our scholarly values, students must cite any AI-generated material that informed their work (this includes in-text citations and/or use of quotations, and in your reference list). Using an AI tool to generate content without proper attribution qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Option 4 – Customized Policy Generative AI Policy

Faculty may create a customized policy that is unique for a specific course with consultation from the department chair. Faculty are encouraged to view *Texas A&M University's Generative AI Syllabus Statement Considerations* when preparing a customized AI policy.
