(CETE) Catalog Course Description: This four credit course will introduce Python programming language for information and cyber security applications. Students will learn the necessary theoretical background in the lecture and will learn writing Python codes in the lab for different subjects including: socket communication, web security and testing, penetration testing, ethical hacking tools and applications, encryption, operating system communication, and APIs, etc.

(CSEC) Catalog Course Description: This course covers advanced penetration testing mechanisms and tools, such as ethical hacking tools. It will focus on advanced penetration testing tools to find vulnerabilities in applications, operating systems and network communication and APIs, etc. Students will analyze the impact of pre and post security event/incidents in a business environment.

(CETE) Prerequisites: Grade of C or better in each of: : MATH 1314, CSCI 1436 (or CSCI 1336 and 1136), CSCI 1437 (or CSCI 1337 and CSCI 1137), and CSCI 2436 (or CSCI 2336 and CSCI 2136) or CISA 3309 (or CISA 4309).

(CSEC) Prerequisites: Grade of C or better in CSEC 1437 or CSCI 1437, CSEC 1360, CSEC 4324 or CISA 4324.

Course Objectives: The objective of this course is to expose students to the concepts behind wireless/mobile technologies and their relevant security issues (vulnerabilities/defenses) from both a theoretical and practical perspective.

Student Outcomes: Upon completion of this course, the student will be able to:

- 1) Perform comprehensive penetration testing on systems and networks to assess and verify their security posture, documenting the methods and outcomes accurately.
- 2) Analyze and articulate the legal and ethical responsibilities associated with penetration testing, including adherence to relevant laws, regulations, and professional codes of conduct.
- 3) Implement, communicate, and monitor risk management strategies effectively, utilizing tools such as Kali Linux and VMWare to manage and mitigate identified risks.
- 4) Identify and apply fundamental networking methodologies, demonstrating proficiency in using tools and techniques for information gathering, and developing strategies to protect individuals and organizations from cyber-attacks.
- 5) Differentiate between and execute risk assessment, business impact analysis, disaster recovery plans, incident response plans, and contingency plans, ensuring preparedness and resilience in the face of potential cyber threats.

Required Materials:

- **Textbook:** (Not mandatory) *The Ultimate Kali Linux Book: Perform Advanced Penetration Testing Using Nmap, Metasploit, Aircrack-ng, and Empire*, 3rd Edition, published April 30, 2024, ISBN-13: 978-1835085806.
- **Blackboard:** Connect to <http://tamusa.blackboard.com>. You will have lecture notes and other supplementary materials in Blackboard. All class communications will be through Blackboard and students should monitor this several times a day.
- **Computing tools:** Zoom, PC capable of running Kali Linux (VMs, etc), Internet connection.
- **Time:** You are expected to spend 4-8 hours per week for the course. This might vary based on the student's background and during exams/assignment submissions.

Course Requirements every student must fulfill in order to succeed in course:

1. Students should check all course components/tabs of Blackboard to be up-to date with relevant class information.
2. Active participation with the Instructor during in-class sessions is highly encouraged.

Mid-term Exam: There will be a mandatory Midterm Exam (refer to schedule and in-class discussions). Being absent for an exam will result in a grade of zero for that exam and may result in failure of the course. The exams will consist of conceptual questions, and open-ended (case-study style) questions. Exams will be based on lecture notes and class discussion. Quizzes (if any) will follow a similar style as exams, with relevant materials for each quiz discussed during class discussions.

Class Participation: Students are expected to actively participate in regular classes and class discussions.

Assignments/Project: There will be multiple assignments and a semester long project during the course. All submission formats, details will be posted on Blackboard. Students are expected to pay attention to the submission instructions, points may be taken off if the instructions are not followed. Please be advised that the Project requires a mandatory, face-face final presentation (dates will be assigned later).

Make up presentation policy:

By default, there are no make-up options for this course. Please contact the Instructor for more information.

Late Submission Policy:

Late submissions will be accepted, but a penalty will apply as follows:

All submissions will incur a 0.5% penalty for each hour for the first 24 hours after the mentioned final submission deadline, and 20% for each subsequent day, until 0%. Students are advised to pay extra attention to Blackboard for the submission dates. There will be no exceptions to this rule.
