Course Description

This course is a study of motivational appeals and social scientific approaches to creating and evaluating persuasive messages. Emphasis will be on applying theory by both analyzing examples and creating appeals under different circumstances. This course focuses on paradigm persuasion, the traditional form of persuasion in interpersonal communication context. The components and functions of paradigm persuasion will be carefully reviewed at different levels (cognition, affection, and behavior). Other forms of persuasion, such as persuasion campaign, low involvement persuasion, and advertising, will also be introduced and briefly examined.

Learning Objectives

- 1) Understand major theories and principles of paradigm persuasion in different contexts.
- 2) Be familiar with other forms of persuasion in non-traditional platforms.
- 3) Critically evaluate information obtained through independent reading and research.
- 4) Survey and analyze audiences and adapt message strategies accordingly.
- 5) Apply and improve social scientific writing skills.
- 6) Apply theories of persuasion in written and oral discourses.

Tardiness and Leaving Class Early Policy

Attendance Policy

Attendance of class meetings is mandatory. Missing class meetings without prior notice of legitimate reasons will negatively influence your participation grade.

Webex Classroom Policy

Although all the class meetings are conducted online and probably the students attend their class meetings at home or other locations which are not classrooms physically. However, it is the students' responsibility to recognize the online class meetings as formal and regular class meetings in a public university. All the necessary class meeting policies in the formal and regular class meetings in a public university, as well as the penalties associated with the violations of the policies, apply to this class's meetings.

Participation Policy

Participation is a must in class. There are in-class discussions, assignments, and activities in almost all the class meetings. Your participation grade is decided by the quantity and quality of your contribution to the class discussions and activities. Missing class meetings means that you miss the class discussions and activities and therefore will negatively influence your participation grade.

If you don't get involved in class activities but instead do other things unrelated to class, you will be asked to leave the online classroom immediately and receive a zero on your participation grade.

If you miss a class meeting (especially when the instructions of the assignments are given), it is your responsibility to find out what you miss. If you miss the class meeting(s) due to legitimate reasons, feel free to contact me ahead of time. You are responsible for the loss of points for not knowing the instructions because of your absence.

Absent/Late policy of assignments

You are required to take exams as scheduled and turn in all the assignments on the scheduled due dates. The assignments are due at 11:59 pm. of the due dates. Each assignment should be turned in via Dropbox in Blackboard. If you miss an exam or an assignment due date for some legitimate reasons (e.g., illness, death in the family), you are expected, if at all possible, to notify me via the contact information listed above of your situation prior to missing a scheduled exam or an assignment due date. If, for some legitimate reasons, you are not able to contact me prior to missing an exam or an assignment, you need to contact me within 24 hours after the missed scheduled test or assignment due date. Note that unless you are unconscious, kidnapped, incarcerated, or similarly incapacitated there is no excuse for not contacting me within 24 hours of missing a deadline.

An unexcused absence from an exam will result in a grade of zero. Late written assignments will be reduced by 20% per 24 hours they are late (note that weekend days are counted as late days). If an assignment is 72 hours or more late it will not be accepted.

If you are absent from class so that you fail to turn in an assignment or take an exam, the ONLY acceptable form of excuse is:

You must provide written confirmation of your excuse on an appropriate, official paper (e.g., a doctor's excuse on office letterhead or prescription pad).

If it is not provided, in a timely fashion (as described above), the excuse will not be accepted and the appropriate sanction will be applied.

Financial Aid and Verification of Attendance
