Everyday Ethics for the Criminal Justice Professional (3rd Edition) 2023

Course Description

This course examines ethical issues and dilemmas and legal problems in the criminal justice system. Ethical practices affecting decision-making by criminal justice professionals, law enforcement officers, prosecutors, defense attorneys, judges, corrections officers, intelligence community members, and legislative actors will be analyzed and discussed from various perspectives.

Student Learning Outcomes and Core Competencies

1. *Understand the major theories guiding ethical decision-making in criminal justice, intelligence, and legislative work.*
2. *Demonstrate how to analyze real world scenarios through an ethical framework and develop solutions to ethical dilemmas*
3. *Examine diverse opinions about ethical behavior in the context in relation to offenders, society, and the justice system goals.*
4. *Demonstrate the ability to think critically and analyze ethical problems through scholarly writing.*

General Education Goals

1. *To enhance student's literacy skills through assigned readings, discussions, exams, quizzes, assignments, and a written report.*
2. *To increase student awareness of cultural and multi-cultural concerns through the study of criminal justice, intelligence, and legislative ethical issues and how they relate to and affect all cultures,*
3. *To develop and apply critical thinking and analytical skills as they relate to ethical and various social/legal systems,*
4. *To identify and comprehend various ethical issues and social factors that relate to law, the legal system, the intelligence community, the legislative community, and to understand their nexus, and*
5. *To prepare for the advanced study of ethics and ethical behavior in the legal/criminal justice, intelligence, and legislative fields.*

Assessment of Learning Outcomes

All outcomes will be assessed through a combination of quizzes, assignments, exams, class participation, and a written report.

Evaluation of Student Performance

Examinations

There will be 3 exams during the semester. Exams will consist of a combination of multiple choices, true-false, short answer, and fill-in questions. If a student fails to take any exam, he or she will receive a “0” for that portion of the overall course grade

Quizzes/Assignments

A random number of quizzes/assignments will be given during the semester. *Important...while you may have an excusable absence from class, if you are not in class the day or days an in-class quiz or assignment is given, missed quizzes/assignments cannot be made up.*

Written Report

STUDENTS WILL SELECT AN ETHICS RELATED TOPIC and complete a written report. Additional instructions will be provided in class. The report shall contain a minimum of 1,000 words, **NOT** including the cover page, abstract, and reference page. **You are to annotate the total number of words in the report on page 2.**

The report shall comply with the APA writing style for paper format, abstract, cover page, citations, headings, and references. The link to the required APA formatting style is: www.apastyle.org. Go to “Learning APA Style” and to the free tutorial, “The Basics of APA Style.” While current events and media sources will likely be major contributors to class discussions, students will be required to use no less than three (3) **academic** resources for the written report. **WIKIPEDIA AND OTHER NON-ACADEMIC REFERENCES SHALL NOT BE USED AS ACADEMIC, CREDIBLE REFERENCES FOR THE WORK.** The final report **shall** be electronically submitted as a WORD document into Blackboard at the date and time provided in class. The file name shall contain the student’s last name. A written report **grading rubric** is included in this Syllabus. Please review it carefully, as it clearly defines the written report grading structure. Word counts will be verified.

Late Assignments - Late assignments receive a 25% deduction if not received by the date and time shown in the syllabus schedule. **Assignments more than one day late will not be accepted.** Technological issues are not considered valid grounds for late assignment submission. Pay Attention to Detail!

- No Use of Generative AI Permitted

CRIM 4350 assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Students shall not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.
